The development stands within well-tended, communal grounds with parking areas for residents and visitors.

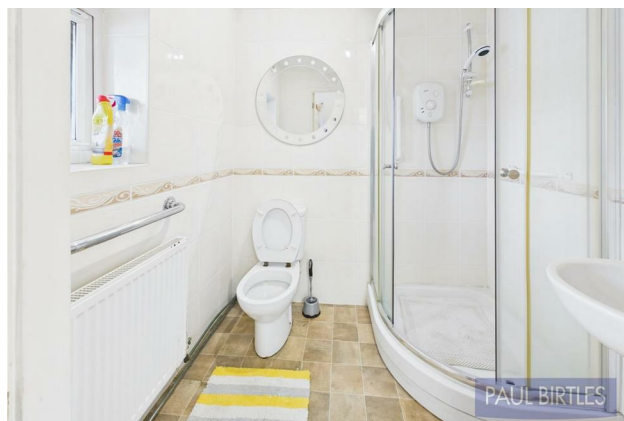

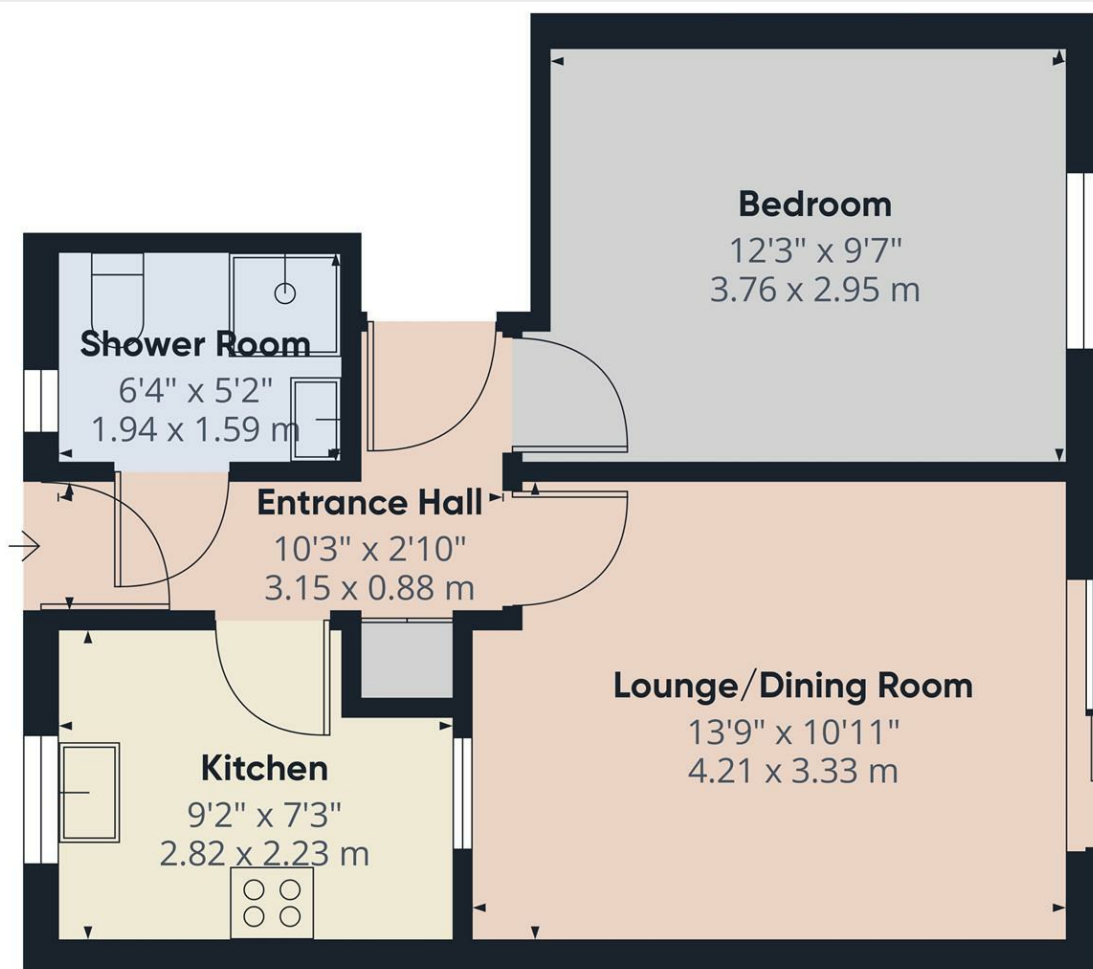
