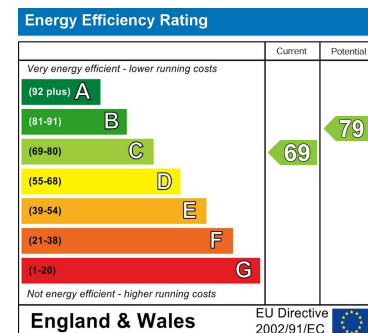
Area Map
