The Property

This four bedroom semi detached family home has been thoughtfully adapted, enlarged and updated to create a wonderful atmosphere and free flowing accommodation that is ideal for the younger family with a large kitchen/dining/family room in particular opening on to the garden deck. The property is well located just a short stroll from Seer Green village centre.

The ground floor porch opens to a hall with cosy living room with wood burning stove to the left and playroom to the right, both linking to the impressive dual aspect kitchen/dining/family room which in turn opens via bi folding doors and French doors onto the garden. There are integrated appliances, a spacious island, underfloor heating and a large skylight in the kitchen area. There is a well fitted utility room and downstairs modern shower room.

On the first floor there are three good sized bedrooms with storage and a modern family bathroom. Stairs lead to the second floor Master Bedroom with impressive en suite bathroom.

The property features gas central heating to radiators with under floor heating in the kitchen/dining/family room.

Outside

The property is situated on a corner plot at the beginning of Hearnes Meadow with a driveway to front providing off road parking for two cars. Gated access from the side opens to a pathway leading to the front door and beyond to delightful secluded lawned gardens with wide raised decking, a bark play area and planters. The whole is nicely secluded and the aspect is southerly

Location

Seer Green is a popular village offering individual shops, two highly regarded pubs and the wellrespected village primary school plus a commuter station providing a fast service to London Marylebone. Buckinghamshire is in catchment for the Grammar School system

Beaconsfield and Gerrards Cross are located close by providing a variety of well-known shops and cafes, two major supermarkets and a Marks & Spencer Simply Food.

Access to the M40 can be gained at Junction 2 Beaconsfield for good road connections to London, Oxford and the M25.

From Beaconsfield take the A355 towards Amersham and turn right into Longbottom Lane and then take the second turning on the left into School Lane. Head up into the village and after passing the Cricketers on the right hand side turn right into Hearnes Meadow where number 49 will be found as the first property on the right hand side.


