Sitting in an elevated position overlooking the Esk Valley between Sleights and Grosmont, the cottage is one of 6 former mine workers cottages built in the 18th century to serve the extensive industry that was found in the Esk Valley at that time. These spacious stone cottages are all of a similar size but No 1 is closest to the road with its position allowing for a small lean to garage on the side which could be developed to create space for a modern vehicles (subject to planning permission if necessary). A few miles from the larger village of Sleights and all its facilities including pub, shops, Dr's surgery and others, the cottages is also a short distance from the renowned steam village of Grosmont, home to the world famous North York Moors Railway and within easy driving distance of Goathland, famous for its association with the BBC's "Heartbeat" series.





The cottage has been empty for some time and now requires an extensive program of renovation and refurbishment to bring it up to modern day requirements but has the fundamental building blocks in place to create a fantastic home. As well as well-proportioned rooms on all floors the cottage has a small garden to the front with a further yard and outbuilding to the rear and as has been mentioned parking to the side. The cottage has been recently rewired downstairs and a new consumer unit fitted and currently benefits from uPVC double glazing to most windows and oil central heating but it is likely these would want to be replaced by any incoming purchaser.




