Natural wood flooring, stairs to first floor, understairs storage, radiator.

LOUNGE/RECEPTION ONE 15'9" x 10'5" (4.82m x 3.20m)

Into bay and recess with double glazed bay window to front, radiator.

SECOND RECEPTION ROOM/DINING ROOM 12'3" x 10'0" (3.74m x 3.07m)

Double glazed door to rear leading to garden with double glazed window, radiator.

THIRD RECEPTION/OFFICE STUDY AREA 11'1" x 10'7" (3.39m x 3.23m)

Double glazed window to side, radiator, natural wood flooring.

KITCHEN 11'11" x 11'5" (3.65m x 3.48m)

Double glazed door to side leading to garden, double glazed window to rear. A range of base and wall fitted units with roll top working surfaces incorporating a single bowl sink, gas point for cooker, plumbing for automatic washing machine, tiled floor, space for fridge freezer.

Access to loft space, radiator.

BEDROOM ONE 12'3" x 10'1" (3.75 x 3.08)

Fitted radiator, double glazed window to rear.

BEDROOM TWO 15'6" x 9'0" (4.74 x 2.76)

Into bay and recess with double glazed window to front, period fire place with tiled sides, radiator.

BEDROOM THREE 10'6" x 27'2" (3.22 x 8.3)

Double glazed window to rear, radiator.

BEDROOM FOUR 9'8" x 6'9" (2.96 x 2.06)

Double glazed window to front

SHOWER ROOM ONE

Double glazed window to rear, low level W.C, pedestal wash hand basin, cubical with overhead shower, fitted radiator, cupboard housing hot water cylinder

SHOWER ROOM TWO

Double glazed window to rear, low level W.C, pedestal wash hand basin, cubical with over head shower.

EXTERIOR TO REAR

Enclosed garden mainly laid to paving

TO THE FRONT

Modest garden with pathway leading to front door via a wrought iron gate.

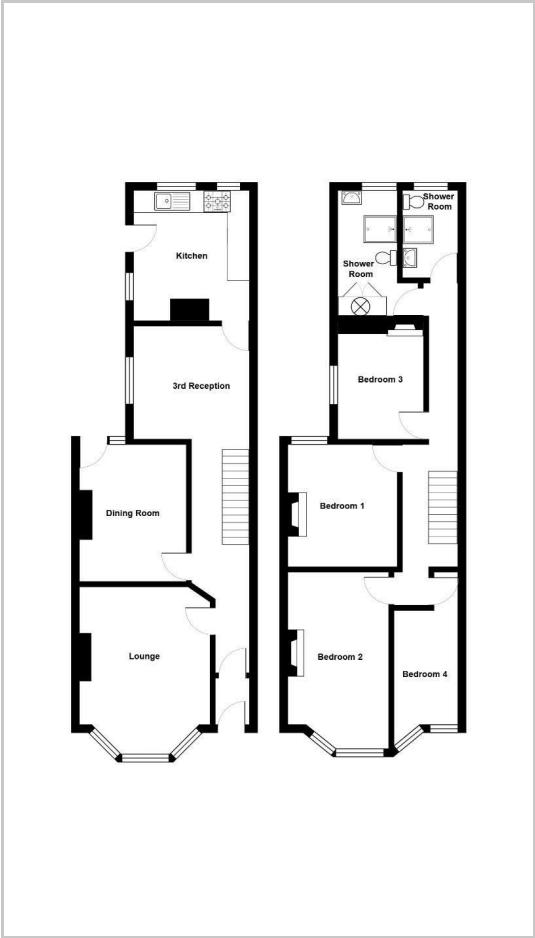
AML (Anti money laundering)

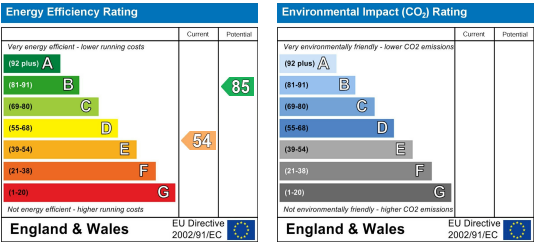
Area Map
