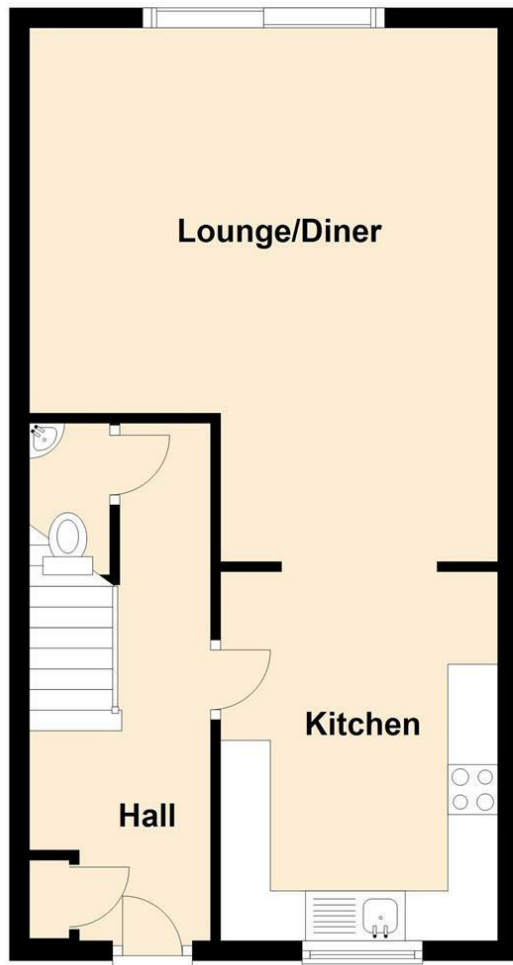
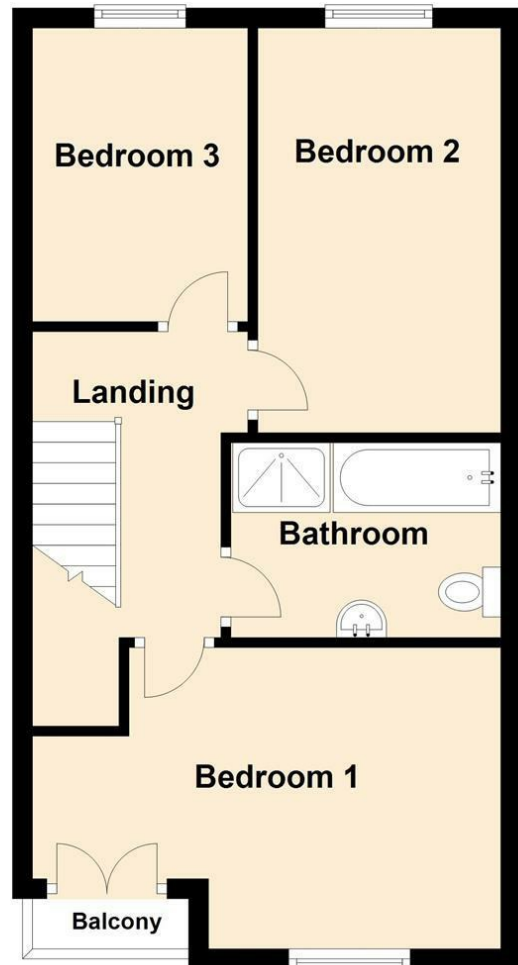


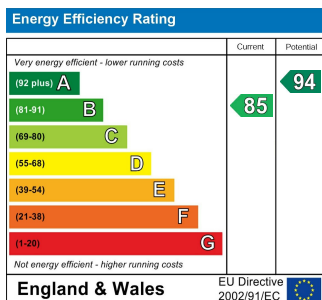
Ground Floor
