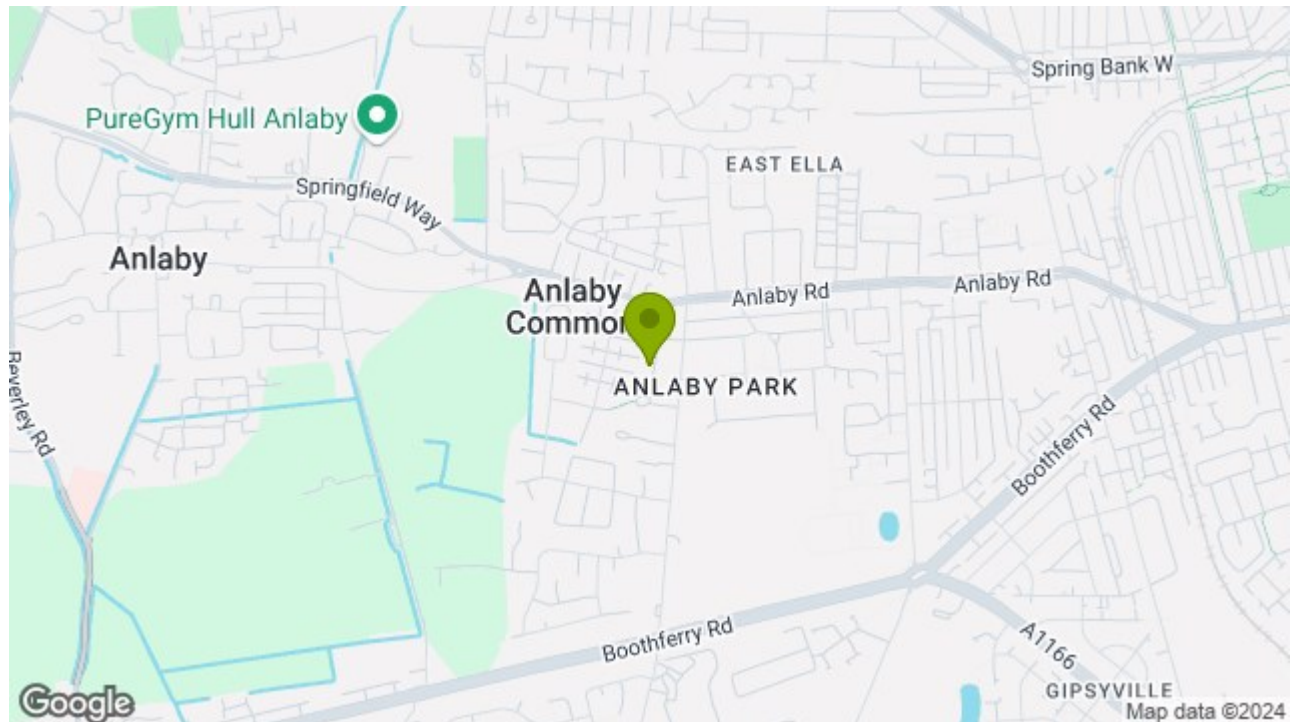

GROUND FLOOR;

ENTRANCE HALL

LIVING ROOM

11'1 x 14'1 into bay (3.38m x 4.29m into bay)

A generous bay fronted living room with feature fireplace housing a gas fire and bi-folding doors leading to the Dining Room.

DINING ROOM

10'1 x 14'5 into bay (3.07m x 4.39m into bay)

A flexible reception room ideal for a dining room or further living space.

KITCHEN

17 x 6'4 max (5.18m x 1.93m max)

With shaker wall and base units, laminated work surfaces and a tiled splashback. With windows to the side and rear, a pantry style cupboard and a rear door.

A bedroom of double proportions with bay window to the front elevation.

BEDROOM 2

11'5 x 9'3 (3.48m x 2.82m)

With three piece suite comprising of a panelled bath with overhead shower and a vanity unit housing a WC and a wash hand basin, window to the rear elevation.

With up and over door, side door and 2 windows to the side elevation.
