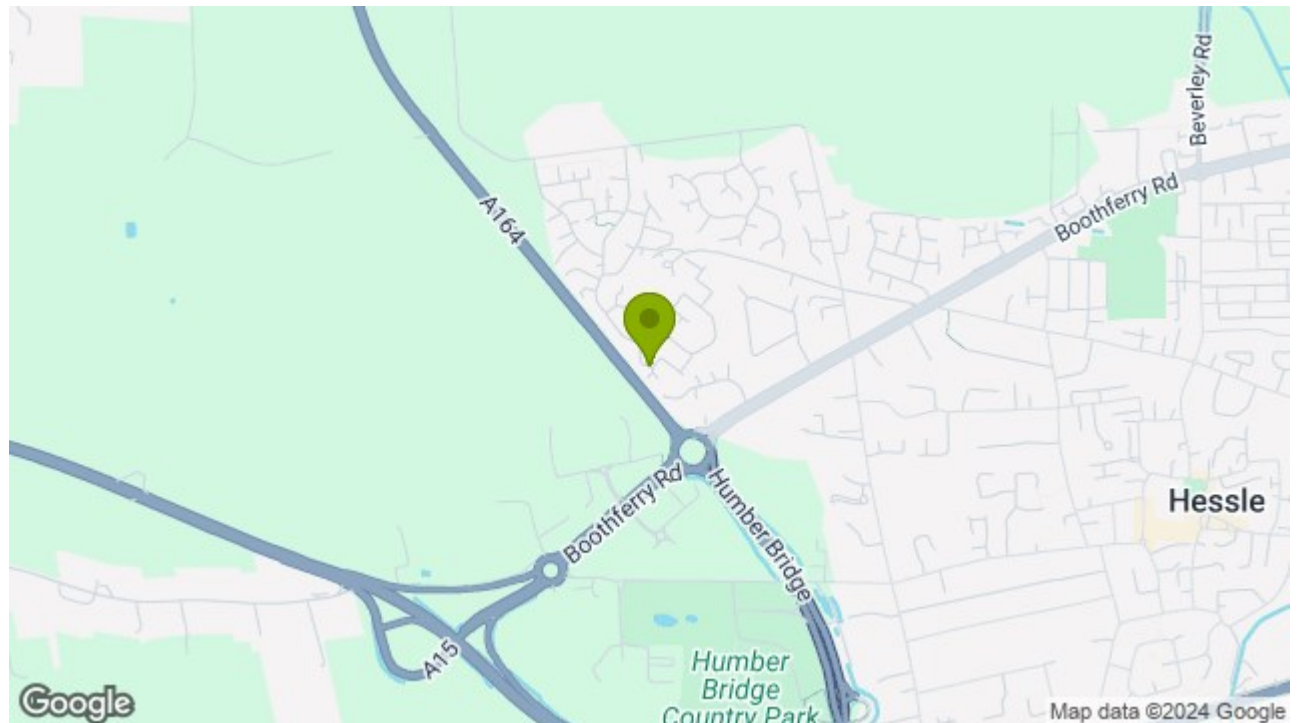

With laminate wood flooring, fixed staircase odd and a window to the front elevation.

DINING KITCHEN

12'11 x 7'6 (3.94m x 2.29m)

With white gloss wall and base units, laminated worksurfaces and upstands. Integrated appliances include an Electric Oven, Gas Hob, Extractor Fan, Fridge/Freezer and a Washing Machine. Further benefitting from recessed spotlights, ample dining space and French doors overlooking the rear garden.

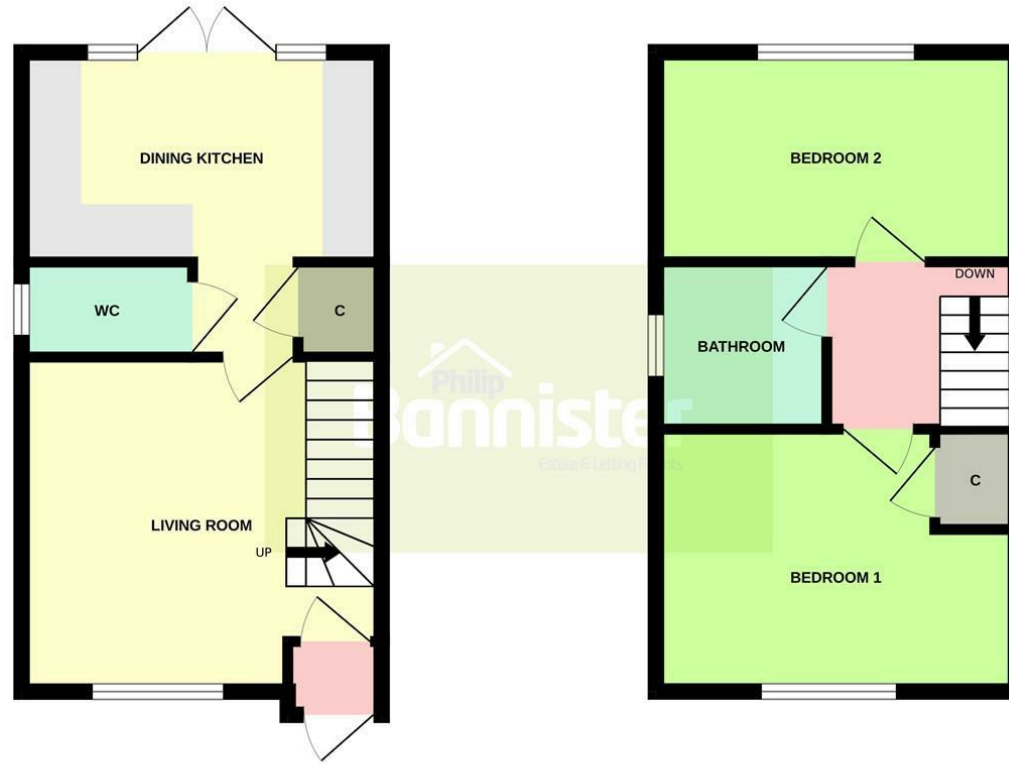
