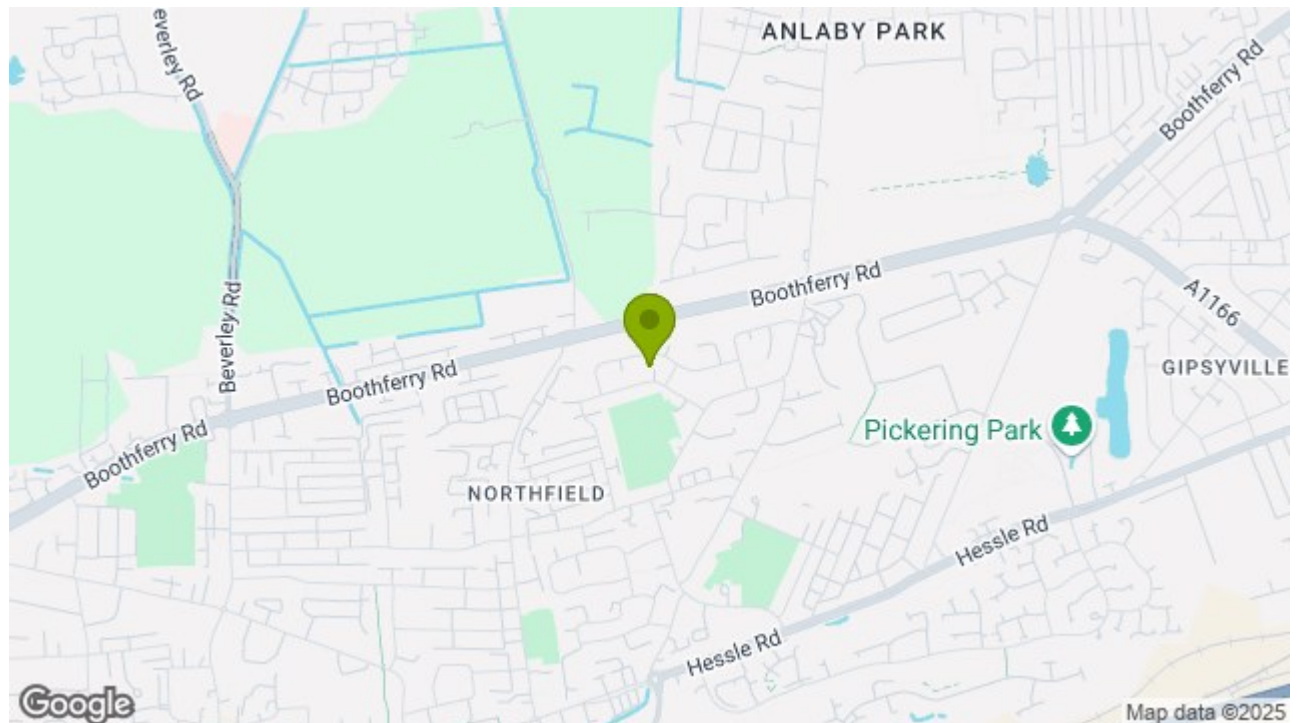

ENTRANCE HALL

Providing access to the accommodation with stairs off.

LIVING ROOM

11'6 x 14'11 (3.51m x 4.55m)

A generous living room with fitted alcove storage units, a feature fireplace and an oriel bay window to the front elevation.
