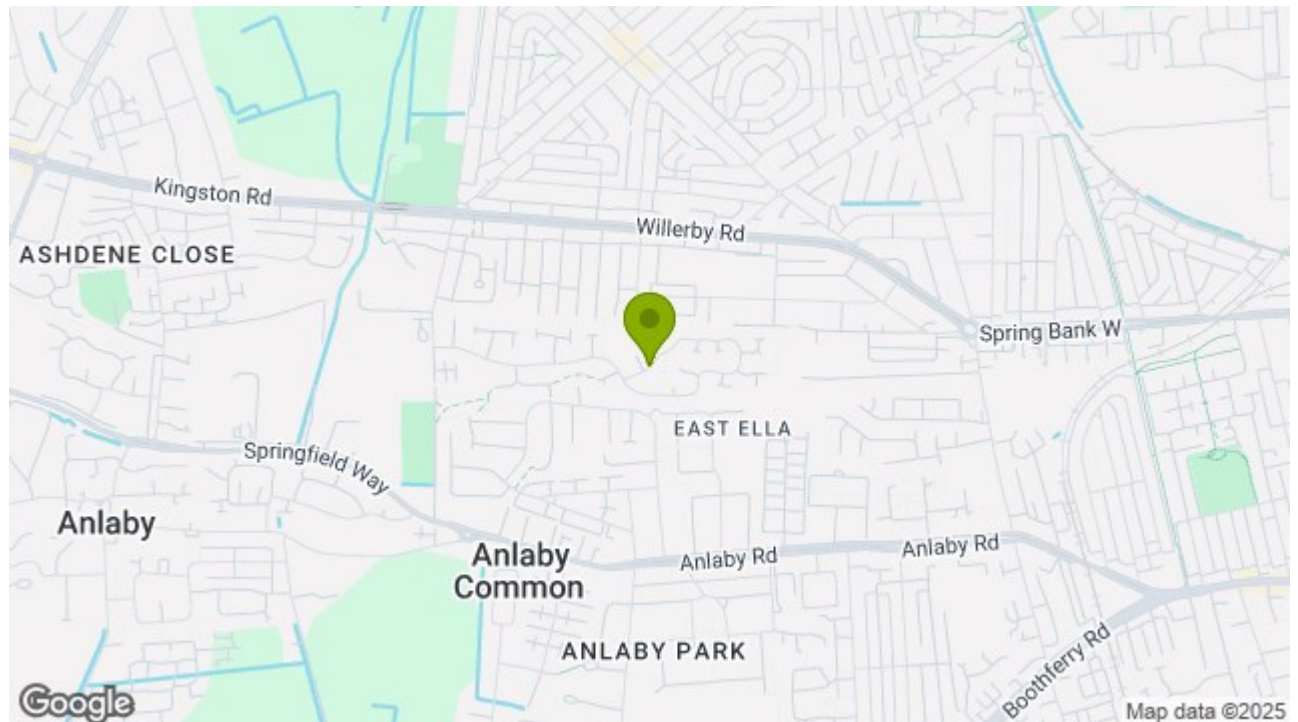

ENTRANCE PORCH

Providing access to the accommodation.

LIVING ROOM

11'6 x 14'1 (3.51m x 4.29m)

A generous living space with laminate wood flooring, window to the front elevation and fixed staircase off.

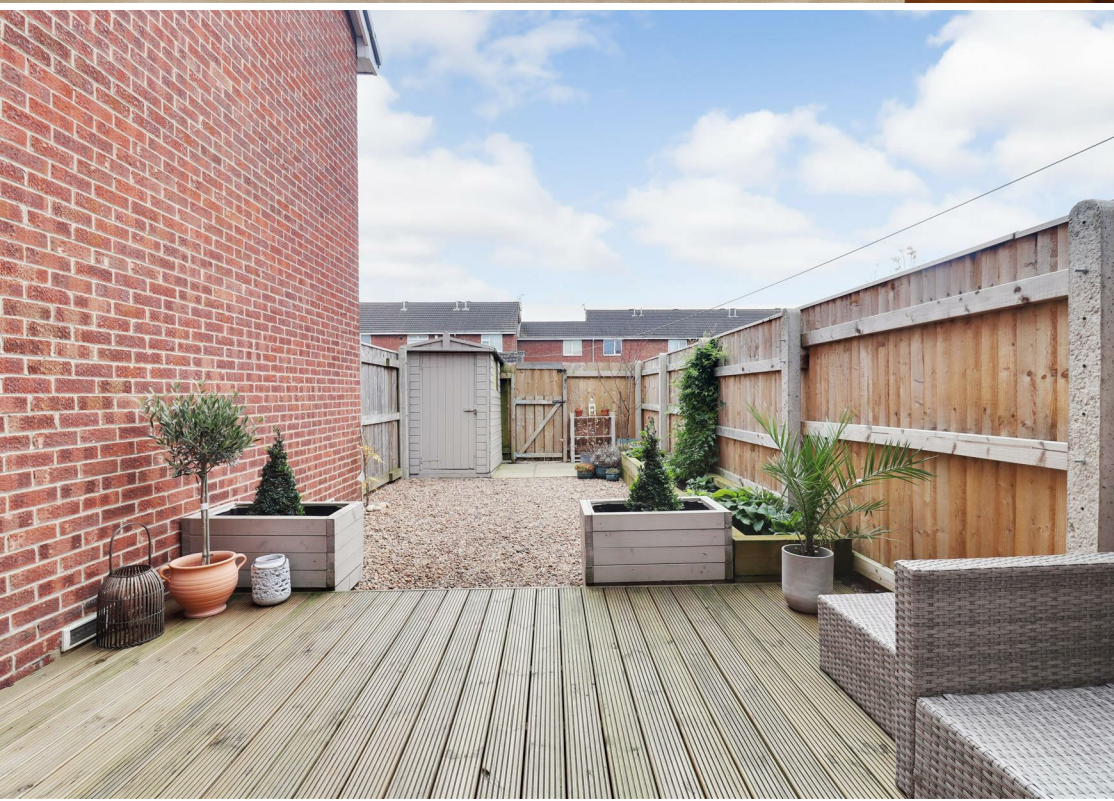

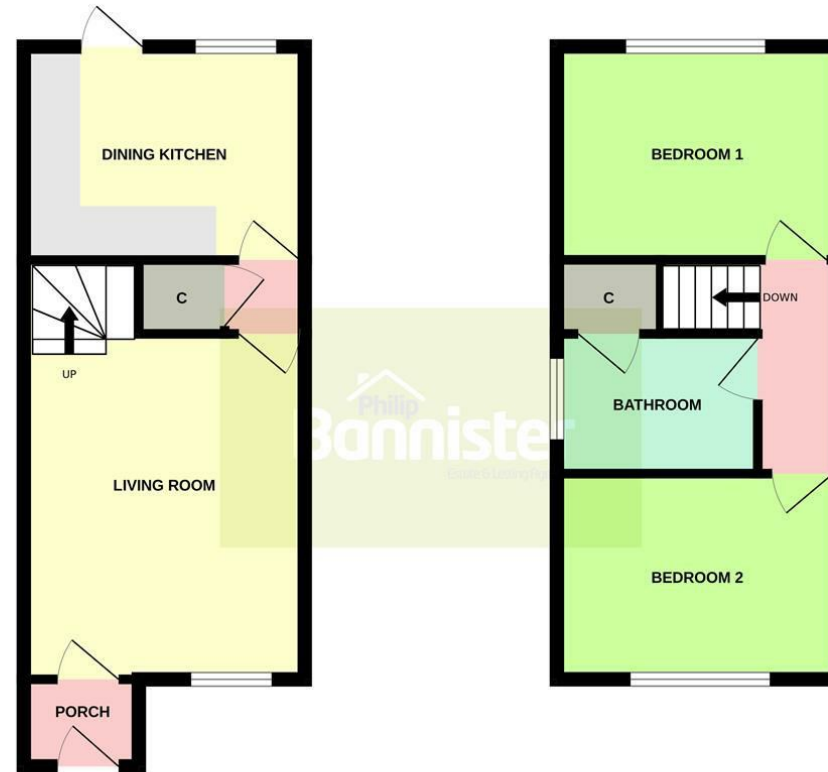
