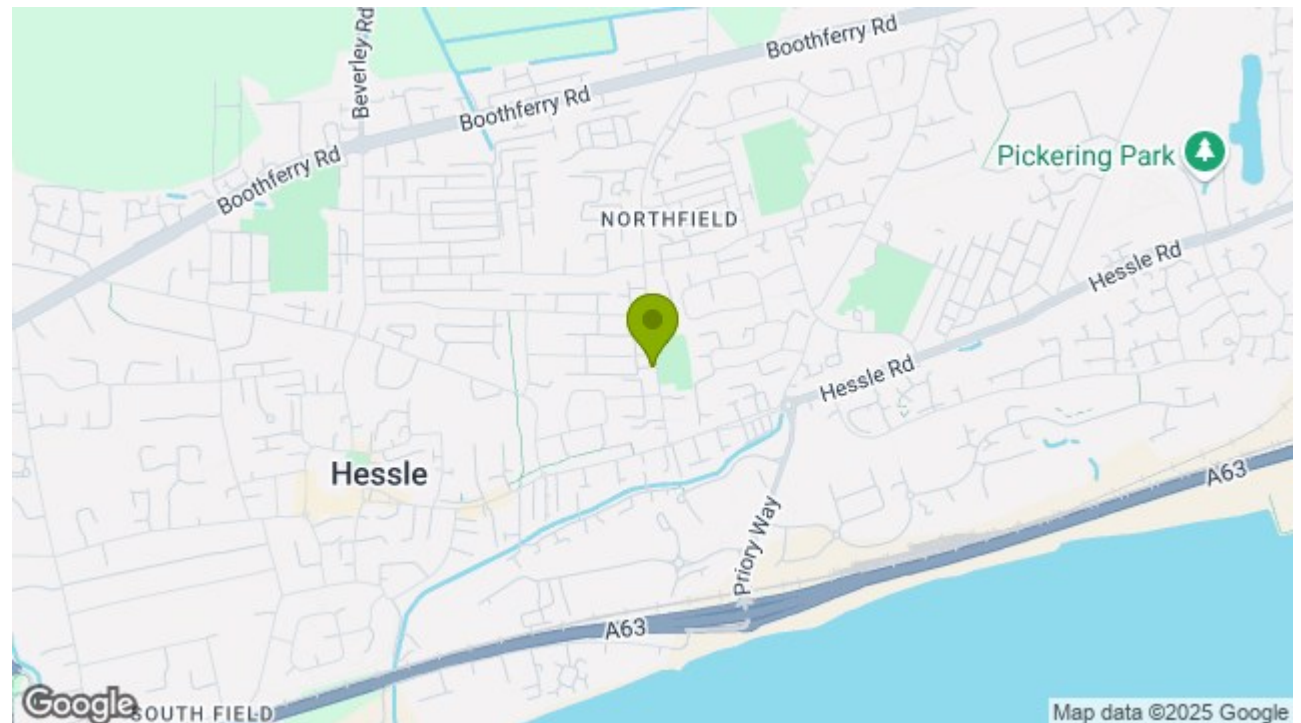

HESSLE

The Town of Hessle is well served for local amenities with first class shopping facilities available within the Town Centre, public transportation & local primary and secondary schools. Good road and rail connections are available with a local train station off Southfield, and the A63 dual carriageway running nearby to the South of the town, allowing convenient access to Hull City Centre and the national motorway network.

ENTRANCE HALL

A welcoming entrance hall with stairs off.

LOUNGE

12'11 into bay x 11'6 (3.94m into bay x 3.51m)

A bay fronted living room with feature fireplace housing a gas fire.

SITTING ROOM

118' x 11'6 max (35.97m x 3.51m max)

A generous reception space ideal for a second sitting room with laminate wood flooring, feature fireplace housing a gas fire, open to the Dining room and French doors leading to the rear garden.

DINING ROOM

5'10 x 8'7 (1.78m x 2.62m)

A further reception space ideal for a dining room with laminate wood flooring and open to the Kitchen and Sitting Room.

KITCHEN

7'10 x 11'4 (2.39m x 3.45m)

With shaker style wall and base units, laminated work surfaces and a tiled splashback. Integrated appliances include a Gas Hog, Electric Oven,

Extractor Hood, Fridge/Freezer, Automatic Dishwasher and a Washing Machine. Further benefitting from recessed spotlights, windows to the side and rear elevation and a door to the rear garden.

A single bedroom with feature wall panelling and a window to the front elevation.

With a three piece suite comprising of a panelled bath with shower attachment, a low flush WC and a wash hand basin. Further benefitting from partially tiled walls, a window to the rear elevation and a radiator.

A small forecourt with hedged border, wrought iron gate and a footpath leading to the front door.

REAR

A lovely rear garden with shaped lawn, raised decking, hedged and fenced borders, footpath leading to the Garage.

GARAGE

With side door, up and over door accessed via the tenfoot.
