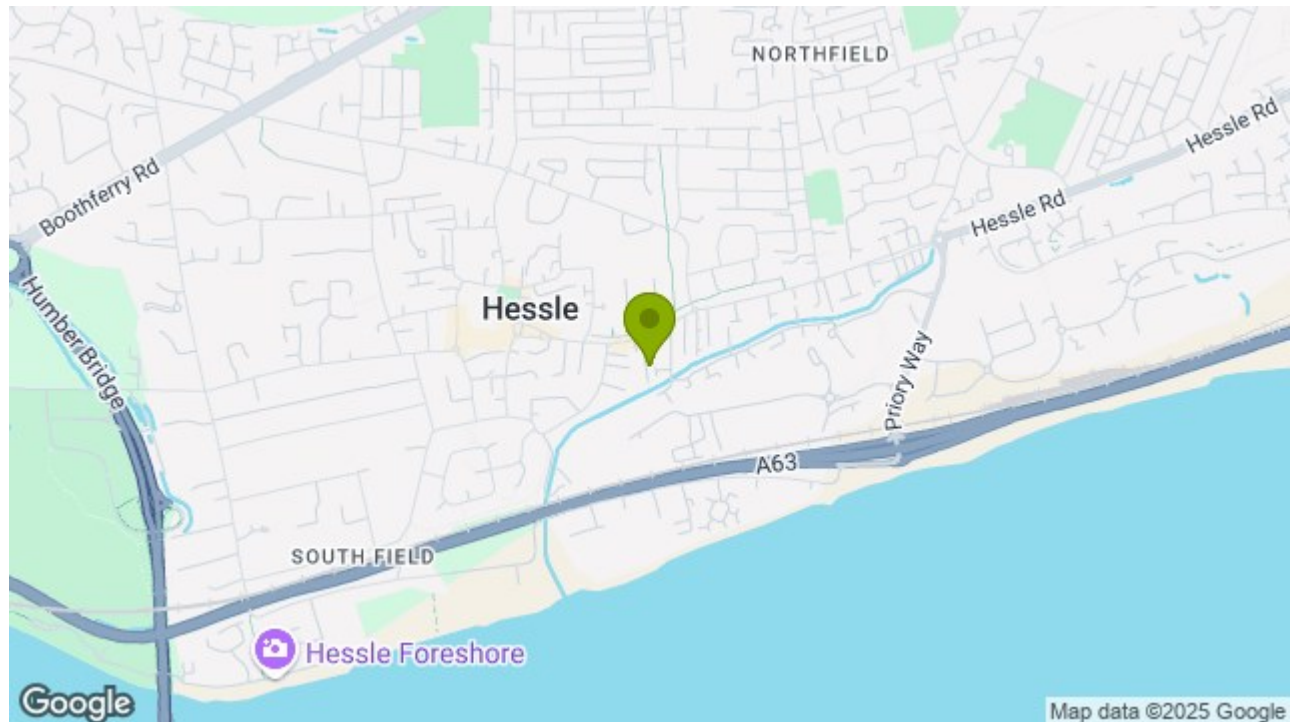

HESSLE

The Town of Hessle is well served for local amenities with first class shopping facilities available within the Town Centre, public transportation & local primary and secondary schools. Good road and rail connections are available with a local train station off Southfield, and the A63 dual carriageway running nearby to the South of the town, allowing convenient access to Hull City Centre and the national motorway network.

25'1 into bay x 9'9 max (7.65m into bay x 2.97m max)

A generous and flexible reception space with ample room for both living and dining with laminate wood flooring, feature fireplace housing a gas fire and a bay window to the front elevation.

KITCHEN

With shaker style wall and base units, laminated work surfaces and a tiled splashback. Integrated appliances include a Gas Hob, Electric Oven and an Extractor Hood. Further benefitting from a window and French doors to the rear elevation, tiled flooring and plumbing for an automatic washing machine.
