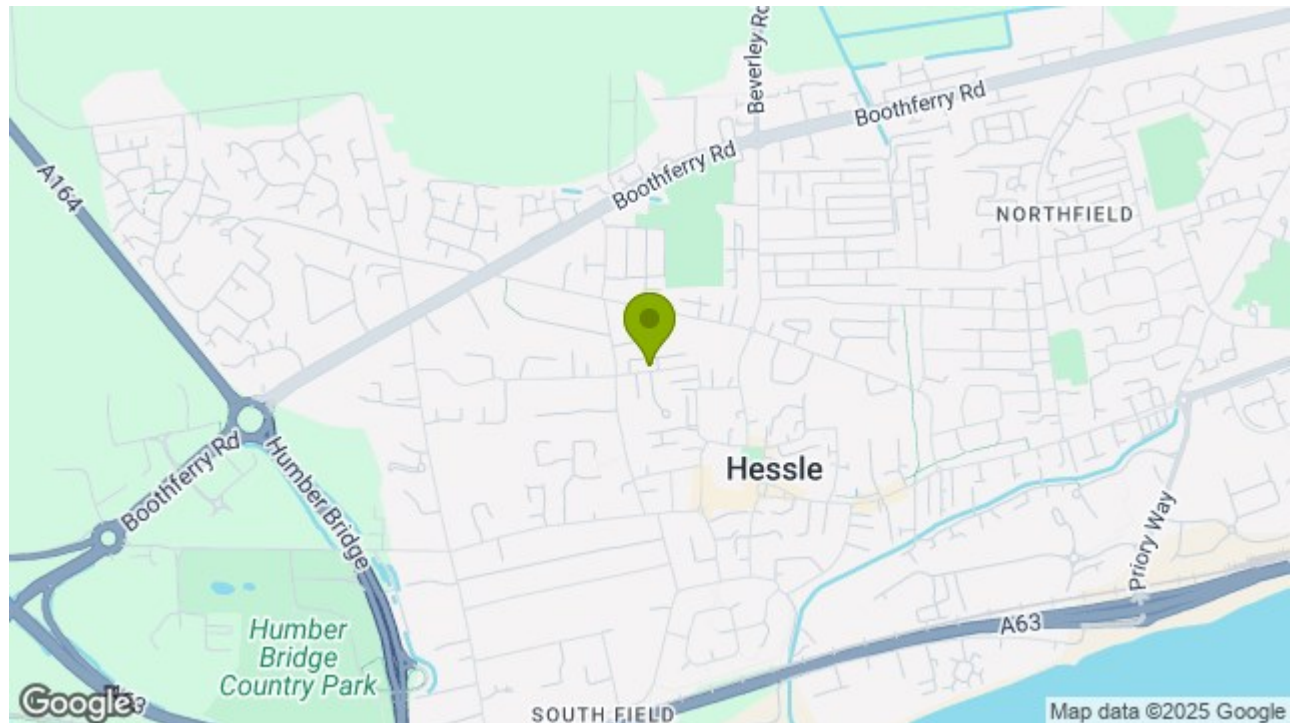

ENTRANCE HALL

Providing access to the accommodation.

THROUGH LIVING ROOM

A generous and flexible reception space with enough room for both living and dining if needed. With bay window to the front elevation and a window to the rear elevation.

KITCHEN

A bedroom of single proportions with window to the rear elevation.

A contemporary three piece shower room with a walk-in shower cubicle, low flush WC and a vanity wash hand basin. Further benefitting from partially tiled walls.

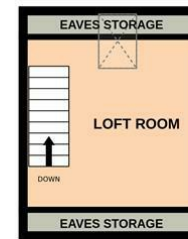
