





GROUND FLOOR:

ENTRANCE HALL

Providing access to the accommodation with stairs off.

LIVING ROOM

A generous living room with bay window to the front elevation, feature fireplace, laminate wood flooring and open to the Dining Area.

DINING AREA

A versatile reception space with laminate wood flooring, a window to the rear elevation and access to the under-stairs cupboard.

KITCHEN

With white wall and base units, laminate work surfaces with breakfast bar and a tiled splashback. With a stainless steel sink unit, extractor hood and a window to the side elevation.

EXTENRAL:

With rear garden and timber fenced boundaries. To the front is a walled forecourt.
