

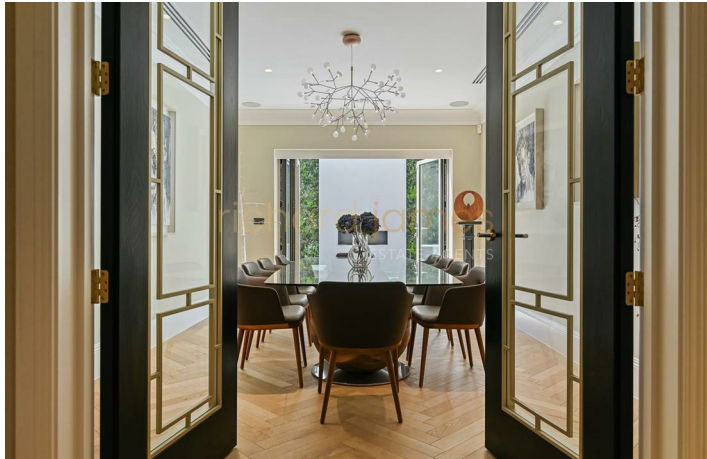

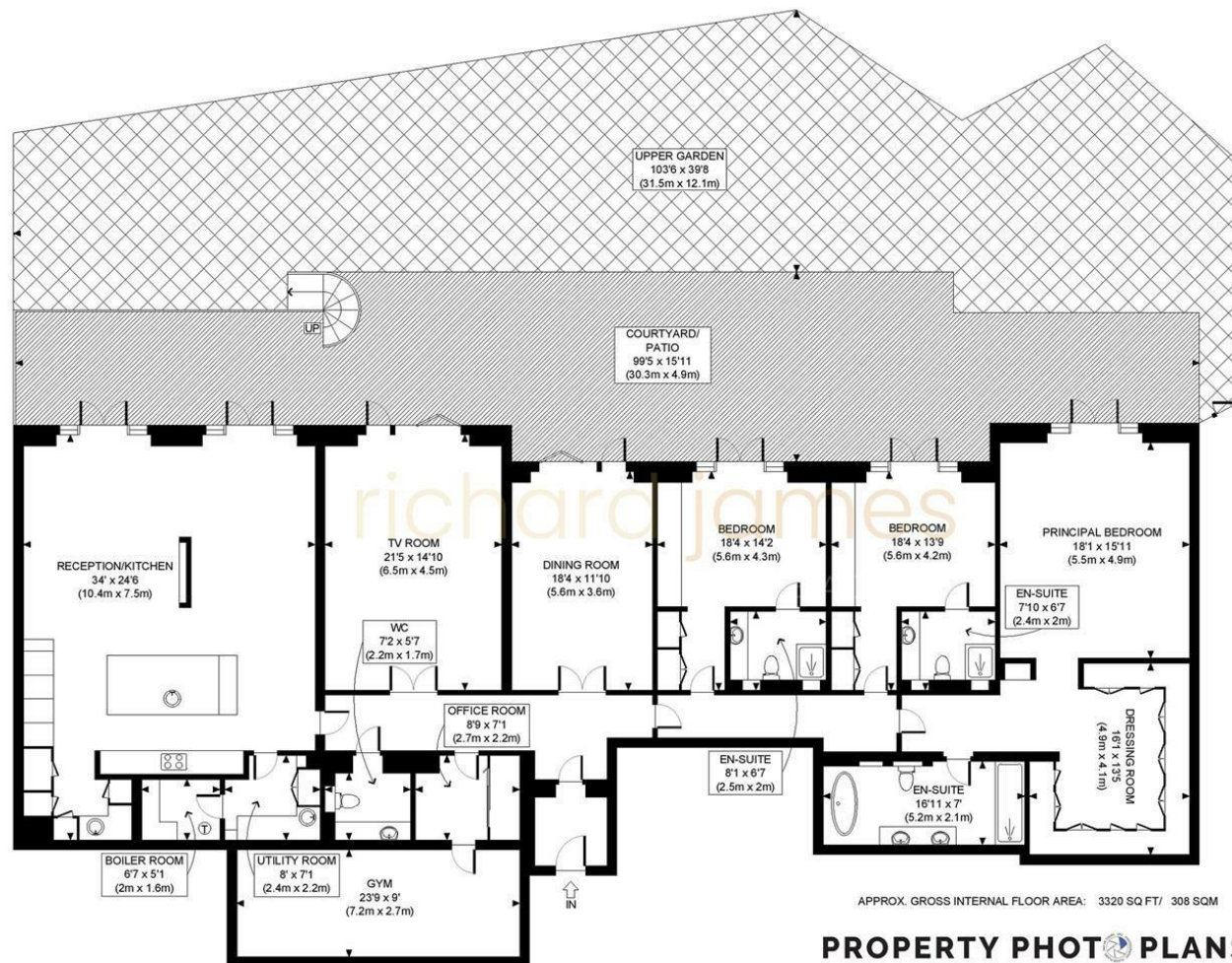












LOWER GROUND FLOOR
