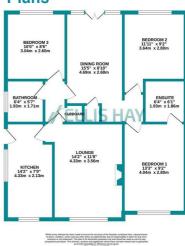

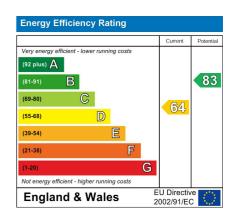
Area Map
