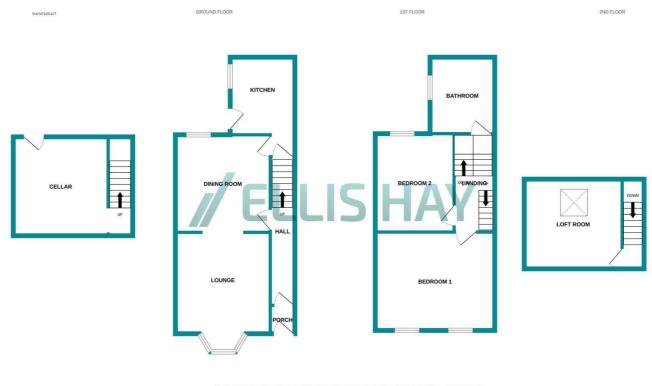

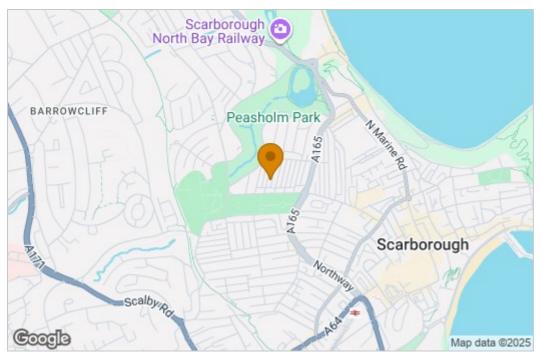
Floor Plan
