The Lounge offers a feature electric fireplace with attractive surround. There is ample space for living and dining room furniture. Two windows provide lots of natural light.

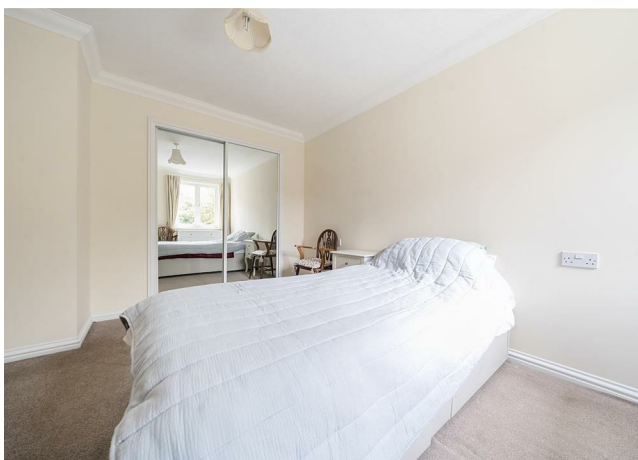

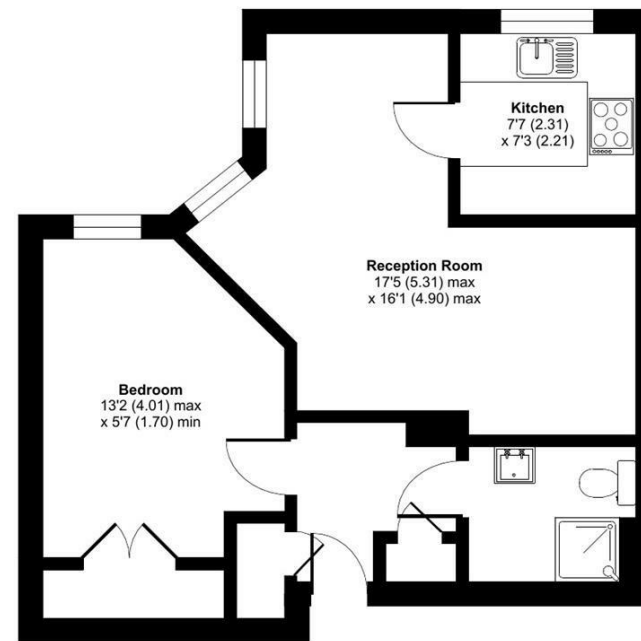
Holding Deposit
