FRONT DOOR AND ENTRANCE HALL

Pathway leading to front door. Front door leading into entrance hall area with white ceiling and emulsion painted walls and fitted carpet. Ceiling lighting. Light switch. Stairs to landing area and door leading into lounge.

LOUNGE DINING ROOM

Door leading from the entrance hall into this open plan lounge dining room. White ceiling, emulsion painted walls and fitted carpet. Ceiling lighting. Light switches and plug sockets. TV socket. Upvc double glazed window over looking front aspect. Upvc double glazed patio doors leading into the rear garden. Door leading into the kitchen. Two radiators.

KITCHEN

Door leading into the kitchen with rear facing aspect. White ceiling, emulsion painted and part tiled walls and fitted lino flooring. Ceiling lighting. Light switch, plug sockets and fuse switches. A range of wall, base and drawer units with fitted handles and laminate worktops. Radiator. Sink with drainer and mixer tap. Upvc double glazed window overlooking rear patio garden. Four ring hob, electric over and extractor above.

REAR GARDEN

The sunny aspect rear garden is easy maintenance and mainly laid to patio with fencing around and a wooden garden shed. Side wooden gate.

STAIRS AND LANDING

Continuation of the hall decor with stairs leading to the first floor and landing area. Light switch. Doors to all first floor rooms. Ceiling lighting. Radiator. Ceiling loft hatch. Built in cupboard.

BEDROOM ONE (REAR DOUBLE)

Door leading into this double bedroom with white ceiling, emulsion painted walls and fitted carpet. Light switch, Plug sockets. Radiator. Upvc double glazed window overlooking rear aspect.

BEDROOM TWO (DOUBLE)

BEDROOM THREE (SINGLE)

BATHROOM

Door leading into this modern bathroom with white ceiling, part emulsion and part tiled walls with vinyl flooring. Ceiling lighting. Radiator. Upvc double glazed window. White bathroom suite consisting of bath with side panel, chrome effect fittings and shower, white we with seat and lid and cistern and white sink with chrome effect fittings.

The front garden is open plan and mainly laid to lawn with pathway leading to the parking and front door.

The property is "FREEHOLD" and is also being offered with "NO FORWARD CHAIN".











