Family Bathroom

Fitted with a suite comprising panel enclosed bath, vanity unit with wash hand basin, w.c and storage, part tiled, radiator and obscured double glazed window to front.

The front garden is mainly laid to lawn with a pathway leading to the front door. The rear garden is predominantly laid to lawn with shrub and plant borders.


