The well-positioned tenanted shop and escape rooms provide income generation of £28,000 per year.

LOCATION

The attractive property is located in Boston Town Centre in Lincolnshire. Boston is an historic market town in the east of England and has a resident population of circa 70,500 having the greatest increase in population percentage of the East Midlands (7.7% from 2011 to 2021, census).

This Commercial Investment is situated in a prominent position on Wide Bargate with nearby occupiers including Next, Morrisons, W H Smith, Santander, Specsavers and Waterstones. It is also within close proximity to the Prime retailing areas of Strait Bargate and Pescod Square Shopping Centre.

The property is also closely located to Central Park, one of the focal points of the town, where many people enjoy the open space. The Park holds a number of events throughout the year and includes a bird aviary, children's play area, skate park, café, public toilets and open lawned park land.

DESCRIPTION

This central shop and offices are arranged over 2 floors with both units having access from the frontage.

The ground floor shop is leased to CEX (franchising) Ltd on a 10 year lease commencing on the 6th January 2017 at £20,000 pa.

The first floor is leased to an escape rooms business on an IRI basis at £8,000 per annum, tax plus VAT commencing July 2023. Copies of the leases are available through our agency.

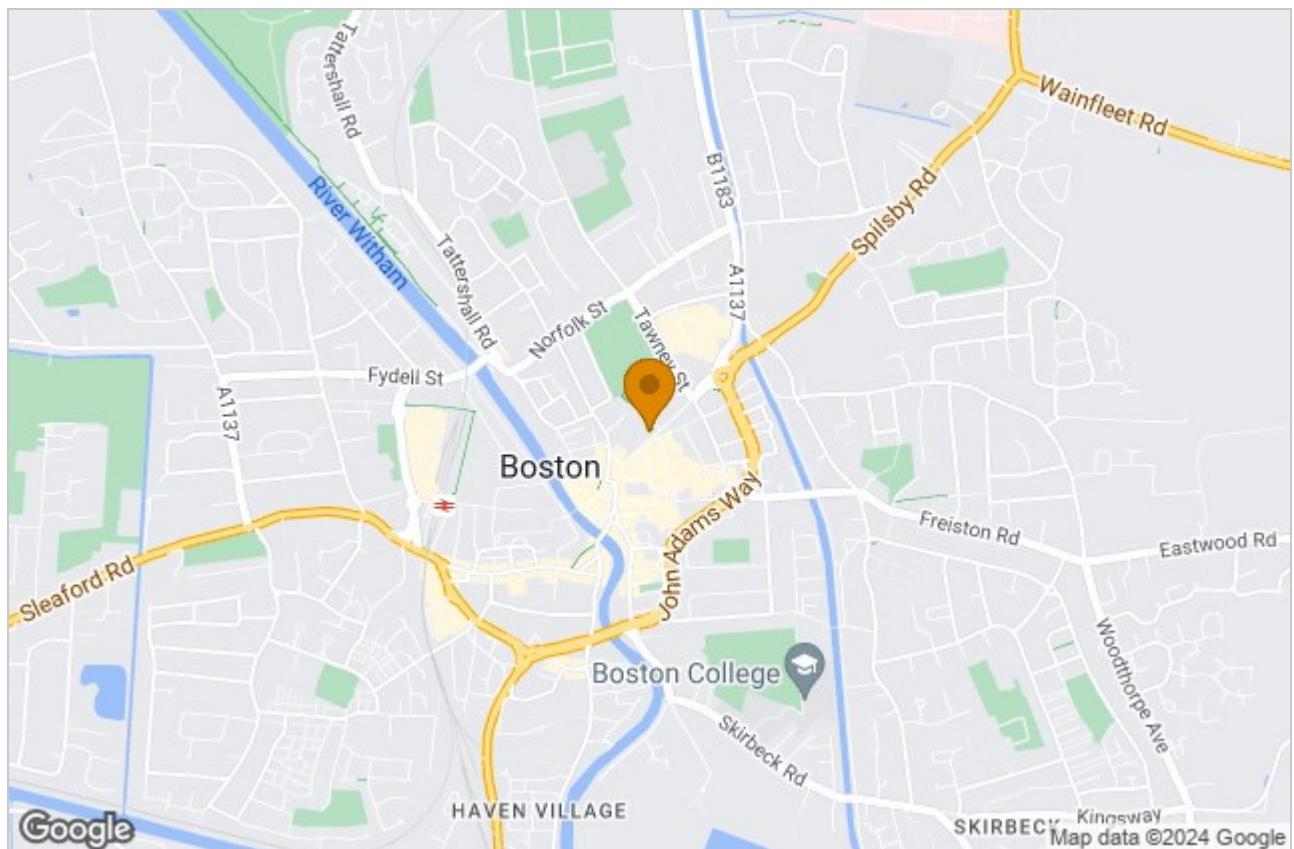
