#### 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Roofing including Roof Space	The roof is of pitched design, clad with concrete tiles and incorporating a tiled ridge. There was access gained to the accessible roof void area via a ceiling hatch within the first floor landing. Access is via a fixed metal ladder. The loft area has been partly floored whilst fibreglass insulation has been laid between the ceiling joists.
	There are a total of eight photovoltaic solar panels on the rear roof elevation together with solar panels.
	Sloping roofs were visually inspected with the aid of binoculars where appropriate.
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. The main outer walls are of modern cavity construction comprising a structural timber fame inner leaf and roughcasted concrete block outer leaf and also incorporating facing synthetic block features.

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

#### Windows, External Doors and The windows comprise uPVC double glazed units whilst the front and rear **Joinery** entrance doors are of uPVC and glazed type. The external roofline fascia boards are formed in timber. Internal and external doors were opened and closed where keys were available. Random windows were opened and closed where possible. Doors and windows were not forced open. **External Decorations** External decorations comprise painted finishes. Visually inspected. **Conservatories / Porches** N/A Communal Areas N/A **Garages and Permanent** There is an integral single car garage forming part of the subjects. Vehicle **Outbuildings** access is gained via a metal roller door to the front whilst there is also a rear pedestrian access door. The garage itself has been plasterboard lined. There were a number of storage items within the garage at the date of inspection. Additional outbuildings comprise two timber and felt sheds/stores. Visually inspected. **Outside Areas and Boundaries** The property occupies a rectangular shaped site with there being areas of garden ground lying to both the front and rear. The front garden is laid with grass whilst the rear garden is laid with paving and grass. The boundaries are formed in timber board fencing. There is a private driveway to the side of the dwelling house providing off road car parking space.

# Ceilings The ceilings are plasterboard lined. Visually inspected from floor level. Internal Walls The internal walls are plasterboard lined

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

# The flooring is of suspended timber construction although we would emphasise that our inspection of floor surface areas was restricted due to the presence of fitted floor coverings and furnishings. There was no access gained to any sub floor areas. Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.

## Internal Joinery and KitchenThe internal skirtings and architraves are of painted timber finish whilstFittingsinternal doors are of modern timber and timber/glazed type.

The kitchen units have been upgraded in the past and comprise a modern range of wall mounted cabinets and worktop surfaces with integrated appliances. There is a utility area off the kitchen which also comprises some modern worktop units.

There is a timber staircase connecting the ground and first floors.

Built-in cupboards were looked into but no stored items were moved.

Kitchen units were visually inspected excluding appliances.

### Water, Plumbing and Bathroom Fittings

Mains supply. The visible plumbing installation is in copper and plastic pipework where seen.

There is a WC off the ground floor hallway.

The first floor bathroom comprises a three piece suite with there being a WC, wash hand basin and bath with mixer shower over. The en suite shower room comprises a modern three piece suite with there being a WC, wash hand basin and mixer shower in tray.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

#### **Heating and Hot Water**

Fixed central heating is provided by the gas fired `Greenstar 15i` boiler which is located within the garage and this served water filled radiators throughout. This also provides for domestic hot water which is supplemented by an electric immersion heater and contained within a modern pre-insulated hot water cylinder which is within a cupboard off the first floor landing. There are solar panels on the rear roof elevation which we understand are connected to the hot water supply.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

#### Drainage

Mains sewer.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

#### Fire, Smoke and Burglar Alarms

There appears to be a compliant smoke and heat alarm system within the property.

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

#### **Additional limits to Inspection**

At the date of inspection the property was furnished whilst the floors were covered.

There was no access gained to any sub floors areas.

There were a large number of storage items within the garage at the date of inspection.

Not all windows were tested during the course of our inspection.


None of the services were tested during the course of our inspection.

#### 4. Valuation and Conveyance Issues

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. 

In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

Graham + Sibbald's total liability to the Client (and any third party relying upon this report) under this Agreement (including liability in contract, tort (including negligence), breach of statutory duty, or otherwise) shall be limited to the lower of the following: a) 25% of the valuation or b) £250,000.

#### 1.4 Generic Mortgage Valuation Report



#### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

#### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. 





#### The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP.
