# 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The property comprises a single storey detached bungalow set in approximately 0.6 acres of surrounding garden ground.

Neighbourhood and Location	The subjects are situated within the scattered rural community of Abriachan which itself lies on the north western upslopes of Loch Ness approximately 10 miles south west of Inverness. The property occupies an elevated position with an open outlook across the surrounding countryside and beyond. Immediate surrounding properties comprise scattered residential dwellings and open ground and croft land. All main facilities and amenities can be found within easy commuting distance of Inverness.
Age (Year Built)	Circa 1998.

Weather	Dry.
Chimney Stacks	There is a single chimney head of rendered stone construction.
	Visually inspected with the aid of binoculars where appropriate.
Roofing including Roof Space	The roof is of pitched design and clad with corrugated metal sheeting. Limited access was gained to a small roof void area via a ceiling hatch within the Kitchen. Fibreglass insulation has been laid between the ceiling joists. There are limited roof void areas only, with the remainder of the property comprising vaulted ceilings.
	Sloping roofs were visually inspected with the aid of binoculars where appropriate.
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

Rainwater Fittings	The gutters and downpipes are of plastic manufacture.  Visually inspected with the aid of binoculars where appropriate.
Main Walls	The main outer walls are of pointed stone construction together with some timber frame and timber clad areas.
	Visually inspected with the aid of binoculars where appropriate.  Foundations and concealed parts were not exposed or inspected.

# Windows, External Doors and The windows comprise timber framed, double glazed units. Joinery There are a total of 4 external timber and glazed doors to both the front and rear. The external roofline fascia boards are formed in timber. Internal and external doors were opened and closed where keys were available. Random windows were opened and closed where possible. Doors and windows were not forced open. **External Decorations** External decorations comprise painted finishes. Visually inspected. Conservatories / Porches Not applicable. **Communal Areas** Not applicable. Outbuildings comprise a timber and felt shed/wood store together with **Garages and Permanent Outbuildings** a PVC polytunnel. Visually inspected. **Outside Areas and Boundaries** The property occupies an irregularly shaped site with there being areas of surrounding garden ground which we understand extends to approximately 0.6 acres or thereby. We would, however, emphasise that we have not taken site measurements and have relied upon information obtained from an online mapping system. The boundaries, where present are formed in post and wire fencing.

Access to the subjects is initially via a shared private track which we understand is under the ownership of Caiplich Farm. This leads to a private driveway area which provides off-road car parking space.

	There are areas of timber cladding to the vaulted ceiling areas.
	Visually inspected from floor level.

Internal Walls	Internal walls are plasterboard lined.
	Some wet walling has been applied within the Shower Room.

	Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Floors Including Sub-Floors	Flooring appears to be of floating construction, although we would emphasise that our inspection of floor surface areas was restricted due to the presence of fitted floor coverings and furnishings.  Given the nature of construction, there was no access gained to any subfloor areas.
	Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Internal Joinery and Kitchen	Internal skirtings and architraves are of painted timber finish, whilst
Fittings	internal doors are of timber type. The Kitchen has been upgraded in the
	past and comprises a modern range of wall mounted cabinets and worktop surfaces with ceramic sink.
	Worktop surfaces with ceramic sink.
	Built-in cupboards were looked into but no stored items were moved.
	Kitchen units were visually inspected excluding appliances.

Chimney Breasts and Fireplaces	There is a modern dual fuel stove within the Living Room area.
	Visually inspected. No testing of the flues or fittings was carried out.

Internal Decorations	Internal decorations comprise painted finishes.
	Visually inspected.

Cellars	Not applicable.

# Mains supply. The electrical installation comprises 13 amp power points and the cable where visible is of PVC type. The electrical meter and circuit breaker unit are contained within the Kitchen cupboard. Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

Gas	Not applicable.

# Water, Plumbing and Bathroom Fittings

Mains supply. The visible plumbing installation is in copper and plastic pipework where seen.

The Shower Room has been upgraded in the past and comprises a modern three piece suite with there being a WC, wash hand basin and mixer shower in-tray.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

## **Heating and Hot Water**

Fixed heating is provided by a range of modern replacement high heat retention heaters together with the stove within the Living Room.

Domestic hot water is provided by a dual electrical immersion heater and contained within a modern pre-insulated hot water cylinder which is within the Kitchen cupboard.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

## **Drainage**

Drainage is to a private septic tank located within the boundaries.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

## Fire, Smoke and Burglar Alarms

We understand that a compliant smoke and heat alarm system is installed within the property.

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

## **Additional limits to Inspection**

At the date of inspection, the property was occupied and furnished whilst the floors were covered.

Given the nature of construction, there was no access gained to any subfloor areas.

There was a small roof void area only for inspection.

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

Insulation has been laid over the roof joists and accordingly a head and shoulders inspection of the roof space was possible only.

Not all windows were tested during the course of our inspection.

No services were tested during the course of our inspection.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a nondisruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

# 4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

## Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

Drainage, we understand is to an exclusive septic tank which we understand lies within the feu. This was not checked or tested. It should be ensured that appropriate registration documents are available.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

Initial access to the property is via a shared private track which we understand in under the ownership of nearby Caiplich Farm. Our valuation assumes that a right of access exists over this and that any future maintenance and upkeep is on a shared and equal basis with the neighbouring properties.

# **Estimated Reinstatement Cost for Insurance Purposes**

£300,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £300,000 (THREE HUNDRED THOUSAND POUNDS STERLING).

## **Valuation and Market Comments**

£240,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £240,000 (TWO HUNDRED AND FORTY THOUSAND POUNDS STERLING).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

# TERMS AND CONDITIONS OF SINGLE SURVEY GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. No

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.



\*\* Which shall be in accordance with the current RICS Appraisal and Valuation Standards (The Red Book) and RICS Rules of Conduct.

#### 1.6 Intellectual Property

All intellectual property rights whatsoever (including copyright) in and to the Report, excluding the headings and rubrics, are the exclusive property of the Surveyors and shall remain their exclusive property unless they assign the same to any other party in writing.

#### 1.7 Payment

The Surveyors are entitled to refrain from delivering the Report to anyone until the fee and other charges for it notified to the Seller have been paid. Additional fees will be charged for subsequent inspections and Reports, including replacement home reports.

#### **DESCRIPTION OF THE REPORT**

#### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

#### 2.2 The Inspection

The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:





# The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. # The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 26 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. #### 1 Heat recovery system for mixer showers

A shower heat recovery system extracts heat from the water in the shower drain and transfers it to incoming cold water. This reduces the amount of energy needed per shower. A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions.
