











SIDE ELEVATION SCALE 1:100






GROUND FLOOR PLAN SCALE 1:100

Plot 2 : Plot size approx. 485 Sq Metres – proposed house size approx. 1,765 Sq Feet









FRONT ELEVATION SCALE 1:100







SIDE ELEVATION SCALE 1:100






GROUND FLOOR PLAN SCALE 1:100
