Set within Vineyard Heights in Mortlake, this two-storey penthouse sits high above the River Thames with sweeping views that stretch from Duke's Meadow and Barnes Bridge to the City skyline, where the Shard and Canary Wharf rise above the horizon. From the sizeable roof terrace, the river feels ever-present, its curve and changing tides defining the rhythm of daily life. The apartment unfolds across two generous floors and has been thoughtfully designed to take full advantage of its elevated position and far-reaching views. The lower level holds two bright

bedrooms, including a primary bedroom with built-in wardrobes and an en-suite bathroom. Both bedrooms have direct river views, while a family bathroom sits off the entrance hall. The upper floor opens into a vast open-plan space that spans kitchen, dining and living areas. The kitchen, defined by warm timber cabinetry and granite worktops, is neatly set apart while remaining connected to the main living area. Wraparound glazing draws in natural light throughout the day, offering uninterrupted river views from almost every angle.

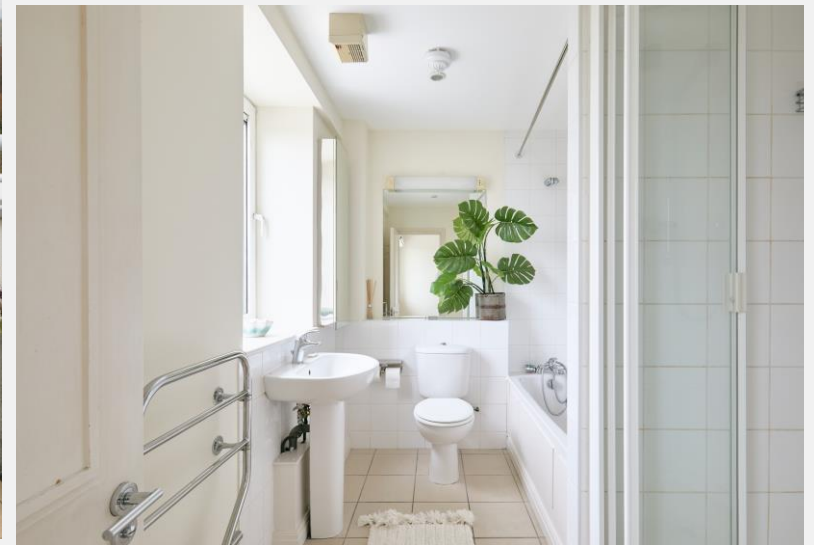
