Stanstead Abbots is located 22.5 miles North of Central London and within easy reach of the capital and other large towns via its many road links such as the A10 and A414.

The lovely village offers an superb array of amenities including convenience store, boutique shops, restaurants and public houses. The River Lee runs through the village and provides scenic walks towards Ware to the West and Broxbourne to the South.

The mainline station is located approximately 0.1 miles from the property and offers services into Liverpool Street in around 36 minutes. Other services are available from Broxbourne providing access to Stansted and Cambridge and services from Tottenham Hale across London.

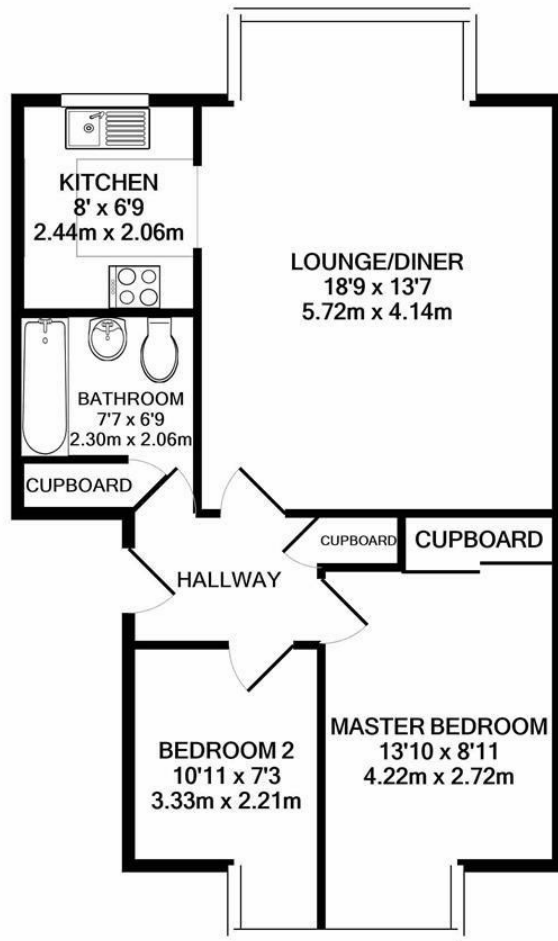

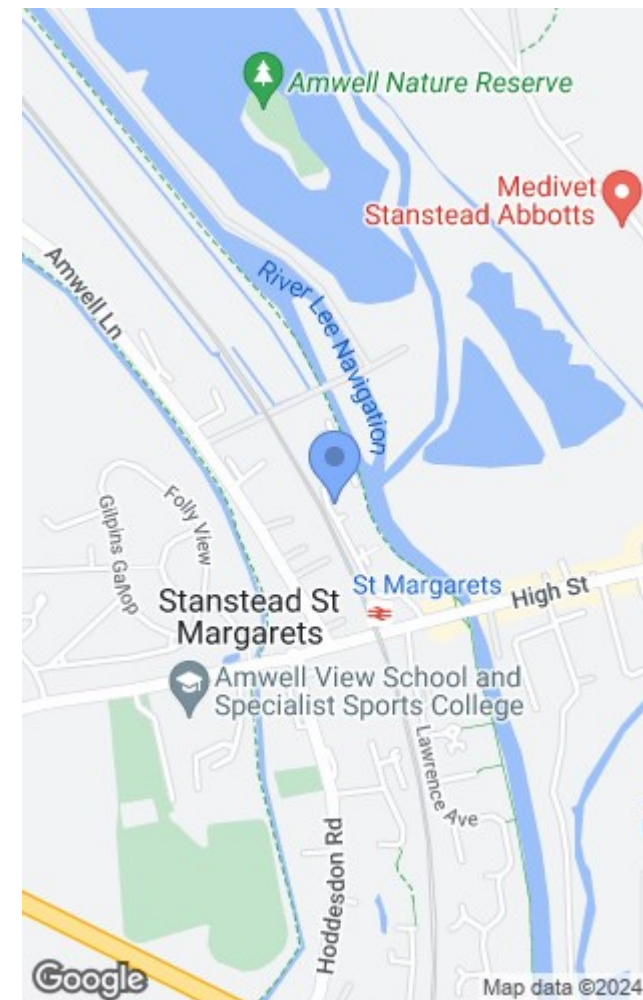
