Inset stainless steel single drainer sink unit with mixer tap, wall mounted boiler serving central heating.

Window to rear aspect. Radiator.

Double glazed window to side aspect. Refitted tiles shower cubical, low level W.C., wash hand basin, heated towel rail, underfloor heating.

#### **LANDING**

Stairs rising from second floor. Door to bedroom one.

#### **BEDROOM ONE**

Double glazed window to rear aspect. Eaves storage. Two radiators. Door to ensuite.

#### **ENSUITE**


Velux window to rear aspect, freestanding bath with mixer tap and shower attachment, wash hand basin, heated towel rail, part tiles walls and floor.
