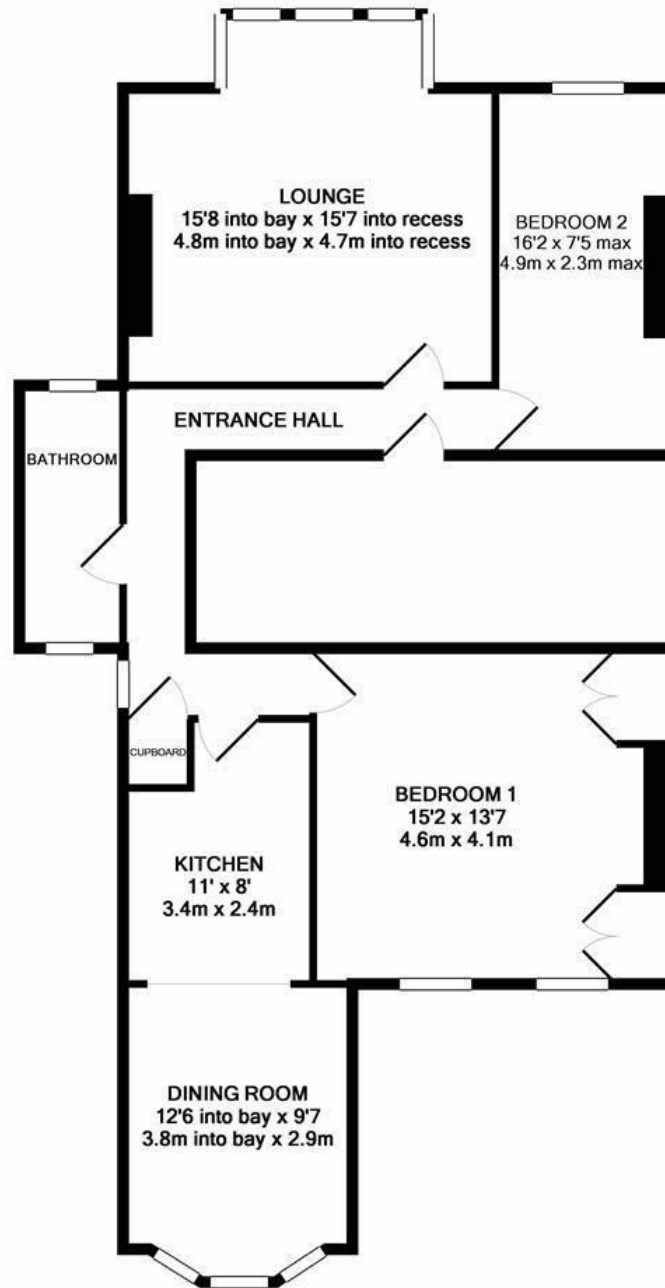

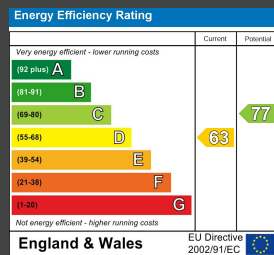
Variation of Contract (Tenant's Request)
