FLOOR AREA 502 SQ FT

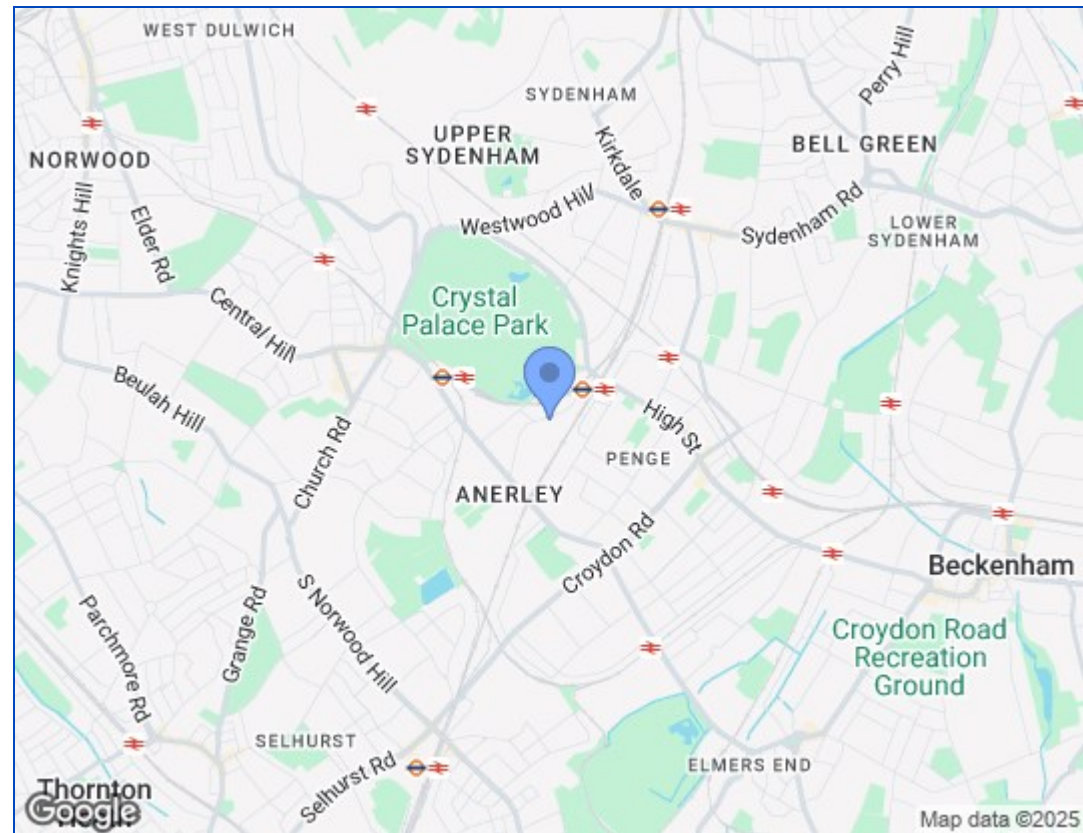
