Description

The subject property is situated close to the entrance to the estate having access off the private road (Longbridge Meadow). Unit 1A is a detached, industrial style of steel portal frame construction with pvc coated sheet steel cladding to the elevations and roof. The original unit was extended in 2013. The minimum eaves heights range from 5.94 m to 6.25 m.

The unit has four roller shutter loading doors off the northern elevation and two off the southern elevation leading into the adjoining secure yard measuring 0.42 acres ($49m \times 35m$). The yard is largely concrete covered and is enclosed by palisade fencing. There is a loading canopy on the southern elevation extending to 64.71 sq m in area.

Location

The property is located on the Longbridge Meadow Industrial Estate, which immediately adjoins Junction 28 of the M5 motorway.

Exeter is approximately 14 miles to the south and Taunton is 23 miles to the north. Junction 28 also provides access via the A373 to Honiton, which is eight miles to the east. Cullompton town centre is less that one mile to the west.
