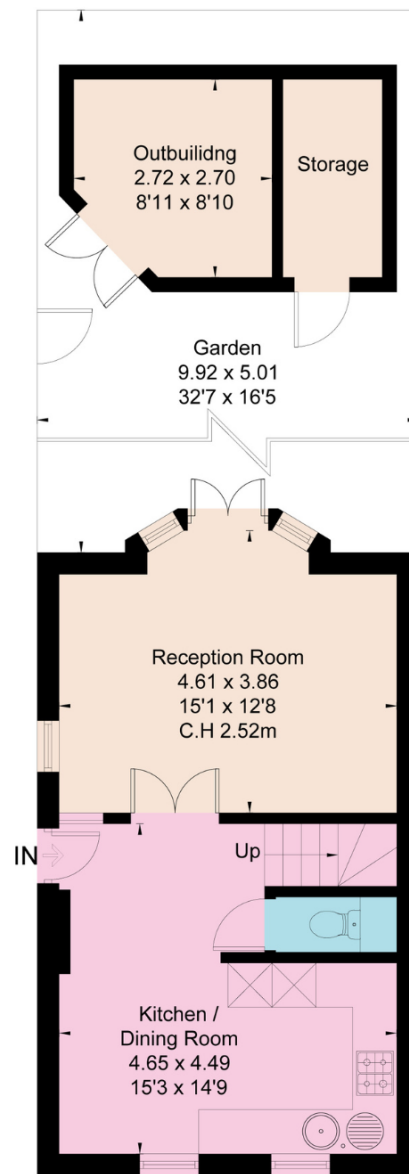
END OF TERRACE HOUSE IN COPENHAGEN GARDENS

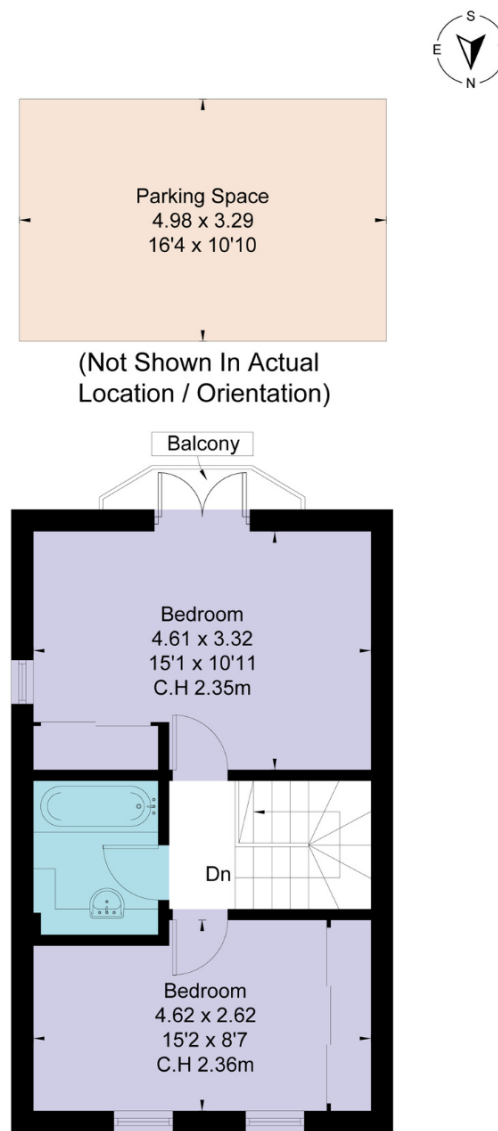








Ground Floor
