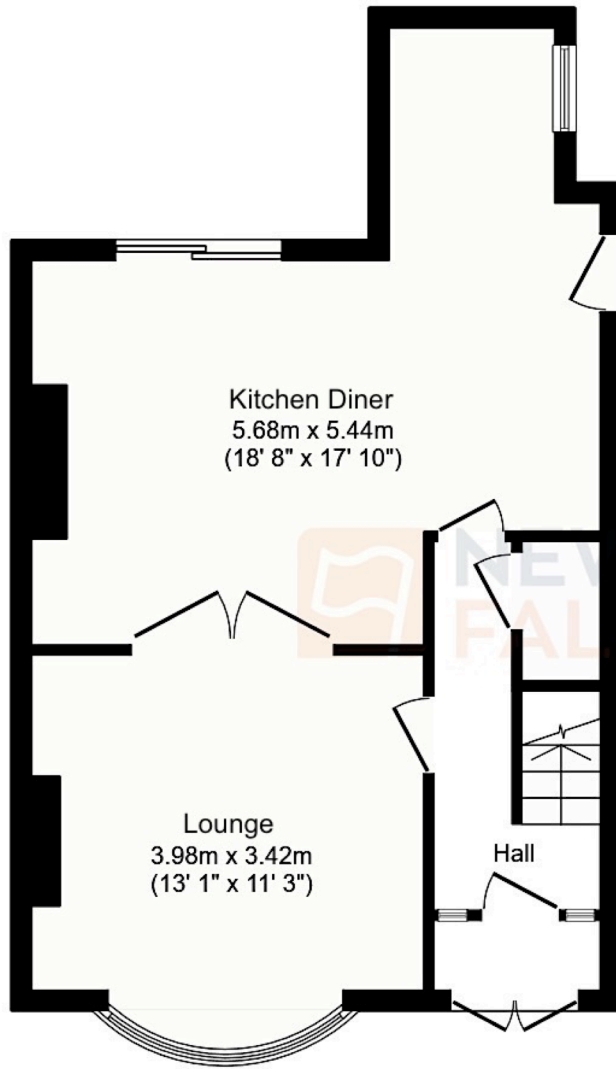

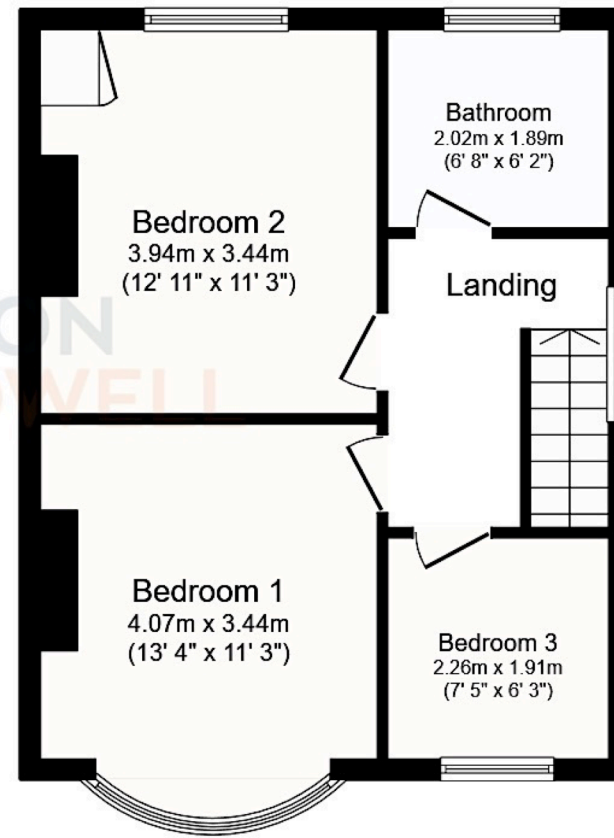






Ground Floor
