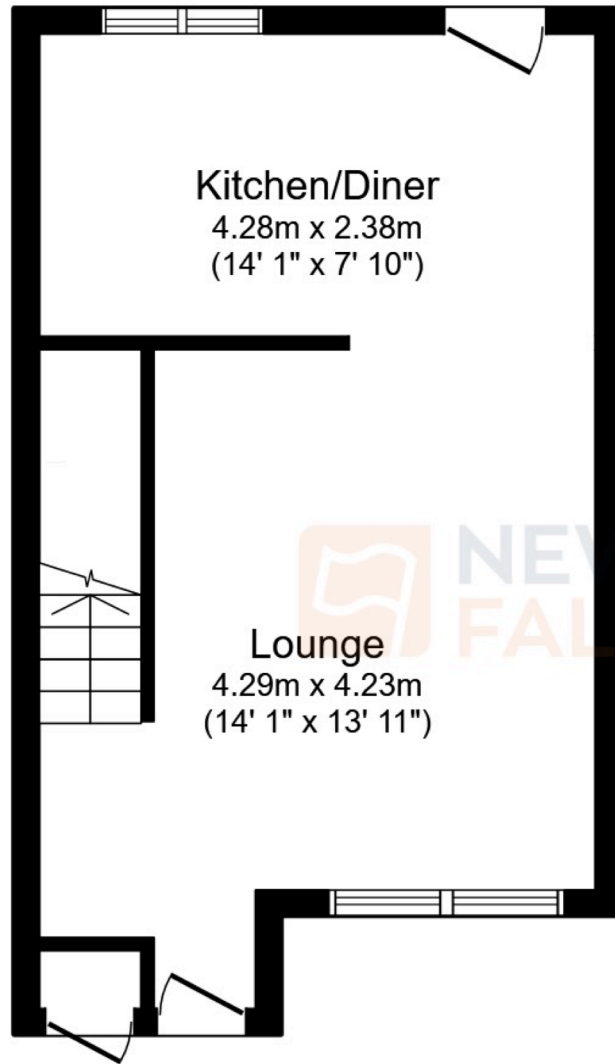

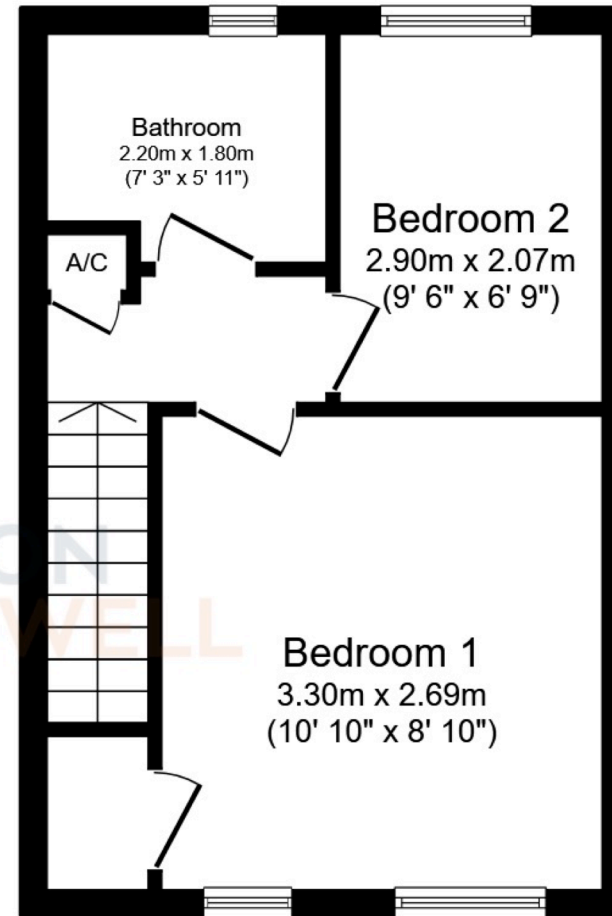






Ground Floor
