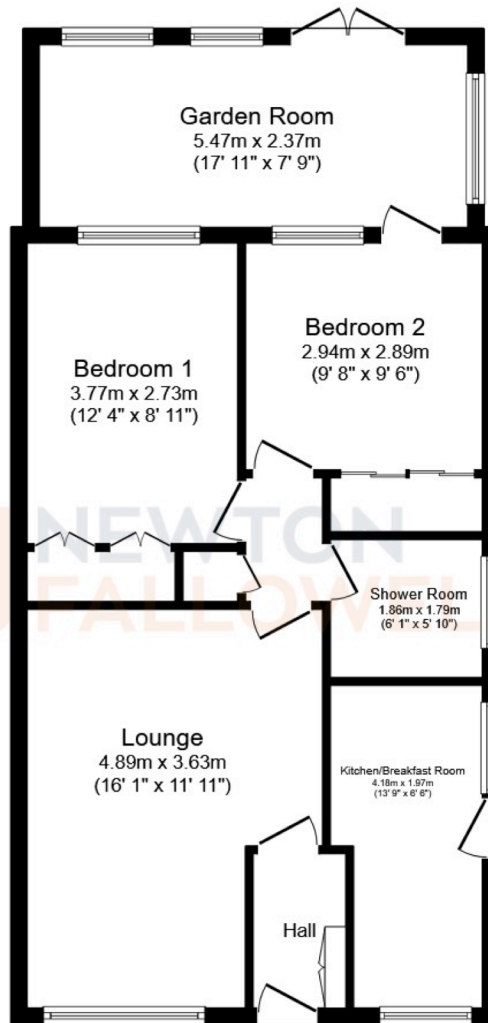












**Floor Plan**
