Ground Floor

Upon entering the property, you are welcomed into an entrance porch, which leads through to the main hallway. The principal reception room features carpeted flooring and is centred around a feature fireplace, creating a warm and inviting atmosphere. Open access flows into the extended dining area, an ideal space for entertaining, enhanced by French doors that open out to the rear garden. The kitchen is equipped with a range of fitted units, roll-edge work surfaces, tiled splashbacks, a sink and drainer, built-in oven, hob with extractor hood above, and space for three additional appliances. Completing the ground floor is a practical lean-to, offering further access to the garden.

First Floor

Upstairs, the landing provides access to three well proportioned bedrooms, making the home ideal for families. The family bathroom is fitted with a modern three-piece suite, including a bath with shower over, a wash hand basin, and a WC. A heated towel rail adds a practical and stylish touch.

Outside

The property is pleasantly positioned within a quiet

cul-de-sac and benefits from a driveway to the front, providing ample off-road parking. The driveway leads to an integral single garage with an up-and-over door. To the rear, the fully enclosed garden offers both privacy and functionality. A paved patio area sits directly behind the property ideal for outdoor dining or entertaining while the remainder of the garden is mainly laid to lawn, bordered by planted borders and fencing. At the far end of the garden, you'll find a rear pedestrian gate providing additional access.

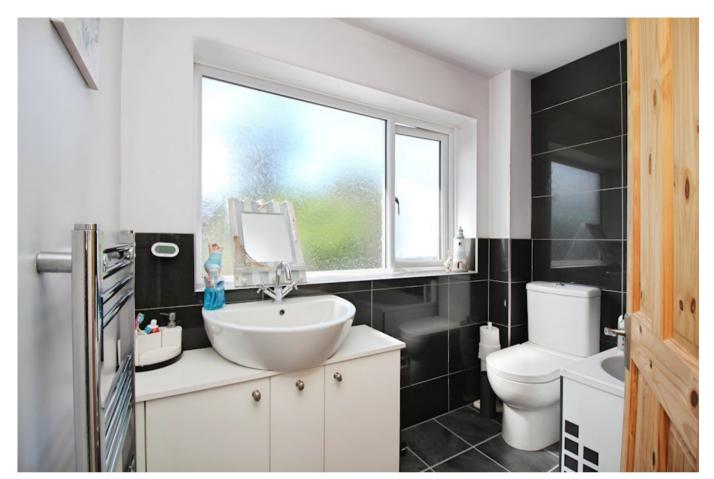

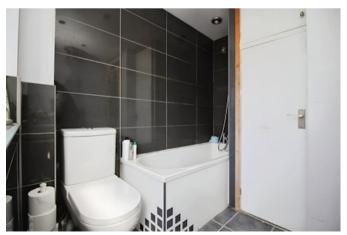
Referrals

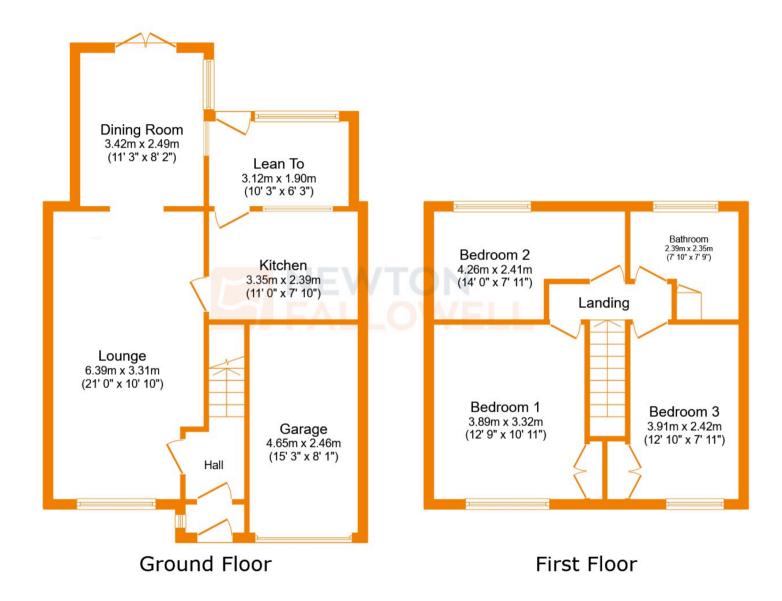
