Boasting an extension to the rear, this traditional semi detached home represents an exciting opportunity for families to acquire a forever home along the popular Braunstone Lane. Having been occupied by the same owners for many years and benefiting from gas central heating, the layout includes an entrance hall, enlarged reception room, dining room, kitchen and shower room, with the first floor offering three bedrooms. The plot boasts a larger than average driveway offering parking for multiple vehicles with a mainly laid to lawn garden to the rear with a raised decking area perfect for outdoor entertaining. Just a short walk away from the local amenities and conveniently positioned for easy access to the M1 and City Centre, an early viewing is therefore strongly recommended to avoid disappointment.

Ground Floor

Upon entering the home, you are greeted by a welcoming entrance hall with a staircase rising to the first floor. To the right, the extended, full-length reception room provides a spacious and comfortable area for family living and relaxation, featuring French doors that open directly to the rear garden.

Double doors lead into the formal dining room, which flows seamlessly into the kitchen, creating an open-plan feel that's ideal for entertaining. The kitchen is well-equipped with a range of wall and base units, complemented by a built-in double oven, hob with extractor hood, sink with drainer, and space for additional appliances.

Completing the ground floor is a modern shower room, fitted with a three-piece suite including a shower cubicle, wash hand basin, and WC, all set against complementary tiling.

First Floor

Upstairs, you'll find three bedrooms, including two

comfortable doubles. There's also excellent potential to reconfigure the layout to create a bathroom alongside three bedrooms, offering added flexibility for future needs. The third bedroom includes a built-in cupboard that houses the gas central heating boiler.

Outside

A particular feature of this traditional property is the substantial plot which affords a larger than average driveway to the front providing off street parking for multiple vehicles. To the rear is a larger than average garden offering a raised & screened decking area providing the perfect space for outdoor sitting and entertaining.


