MODERN HOME! - Occupying a desirable position not overlooked from the front, walk in and be surprised by this contemporary styled four bedroom semi detached house situated on the popular & convenient St Mary's Park development, built on the site of the former St Mary's Allotments, within close proximity to Freemans Common, Leicester. An ideal family home, the well proportioned accommodation is set across three floors and benefits from gas central heating and double glazing. The layout offers an entrance hall, lounge, inner lobby with access to a downstairs WC and a kitchen diner. Upstairs you will find two bedrooms and a bathroom, with a further staircase rising to two further double bedrooms and shower room. Sitting on a larger than normal plot, there is off road parking and gardens to the side and rear. An early viewing is strongly recommended.

Ground Floor

Upon entry to the accommodation you step into the welcoming entrance hall with a staircase rising to the first floor and a door leading through to the reception room offering dual aspect glazing. A door leads through to the inner lobby offering a useful storage and access to a guest WC. The full width kitchen diner is fitted with a modern range of wall mounted and base units with complementary work surfaces over and matching splashbacks. Features include an inset sink and drainer, built in oven, four ring hob with extraction hood above and space for appliances. Enjoying the use of a breakfast bar, a door gives access to the aarden.

First Floor

Moving upstairs, a landing gives access to two full width bedrooms, both neutrally decorated and flooded with natural light by two double glazed windows. The family bathroom is fitted with a contemporary three piece suite comprising a bath with

shower over, wash hand basin and wc, with complementary tiling. A staircase rises to the second floor.

Second Floor

Featuring two full width double bedrooms, the master bedroom being larger than normal and enjoying views of the green space to the front by two double glazed windows. Completing the second floor is the modern shower room fitted with a three piece suite comprising a shower cubicle, wash hand basin and WC. The landing offers a useful built in cupboard and access to the insulated loft space.

Outside

Occupying a larger than normal plot, the property is tucked away at the end of a private driveway and is not overlooked from the front. There is off road parking and access to the rear garden which has been sectioned into three areas, two being low maintenance and the main garden being mainly laid to lawn.

Location

Maris Lane is a residential street situated in the popular Aylestone area of Leicester (LE2). The location offers excellent access to Leicester city centre, the M1 and M69 via Aylestone Road and Narborough Road, as well as nearby bus routes for convenient commuting. Local amenities include shops, schools, parks and leisure facilities, all within easy reach. The area features mainly modern family homes with off-road parking, appealing to professionals and growing families seeking a well-connected suburban setting.
