Accessed via a UPVC double glazed front door, with stairs to the first floor and laminate flooring.

Lounge

With a UPVC double glazed window to the front, wall lights, coving to the ceilings, laminate flooring, understair storage cupboard and double doors into the kitchen.

Dining Kitchen

16' 2" x 8' 11" (4.93m x 2.72m)

A fitted kitchen with matching wall and base units with complementary work surfaces over with an inset stainless steel sink and drainer unit with mixer tap over. There is a Range cooker with stainless steel chimney effect cooker hood over, integrated fridge and ample dining table space. There is also two UPVC double glazed windows to the rear as well as a door leading out into the garden.

12' 6" Max x 9' 9" Max (3.81m Max x 2.97m Max) With a UPVC double glazed window to the front, radiator and built-in storage cupboard.

Bedroom Two

With a UPVC double glazed window to the rear, radiator and built-in double storage cupboard which houses the boiler.

Fitted with a panel bath with electric shower over, pedestal sink and low level W/C. With tiling to the splash backs, extractor fan, heated towel rail and a double glazed window to the rear.

To the rear you will find an enclosed yard with a gate leading to a communal pathway. There is also a brick outbuilding.
