The bungalow offers Entrance Hallway, Lounge, Kitchen, Conservatory, Three Bedrooms and Bathroom. The property boasts a generous corner plot with front and rear Gardens, Garage and Generous Driveway for multiple vehicles.

Ground Floor

Entrance Hall

Accessed via a UPVC door to the front with access to the loft, radiator and storage cupboard.

Lounge

17' x 10' 10" (5.18m x 3.30m)

With a double glazed window to the front, feature electric fireplace and new carpet.

Kitchen

10' 6" x 7' 8" (3.20m x 2.34m)

A fitted kitchen with matching wall and base units with complementary work surfaces over with an inset one and a half sink and drainer unit with mixer tap over. There is an electric oven and hob and extractor hood over. There are a range of built in appliances including a washing machine, dishwasher, fridge and freezer. There is also a double glazed window to the rear and radiator.

With a double glazed window to the rear and a radiator.

Bedroom Two

.10' 10" Plus recess x 8' 4" (3.30m Plus recess x 2.54m)

With a double glazed window to the rear and a radiator.

Bedroom Three

9' 9" x 8' 2" (2.97m x 2.49m)

With a double glazed window to the front and a radiator.

Bathroom

A fitted suite comprising of a corner mains fed shower, bath, low level W/C and pedestal wash hand basin. There is a chrome heated towel rail, tiling to the walls, lino flooring and a double glazed obscure window to the front.

To the front, you will find a shared driveway which leads to the garage. There is a path leading to the front of the property, lawned area, water tap and all enclosed with conifer boarders.

Rear

To the rear, the garden is mainly laid to lawn with access to the side, patio seating area and a garden shed.










