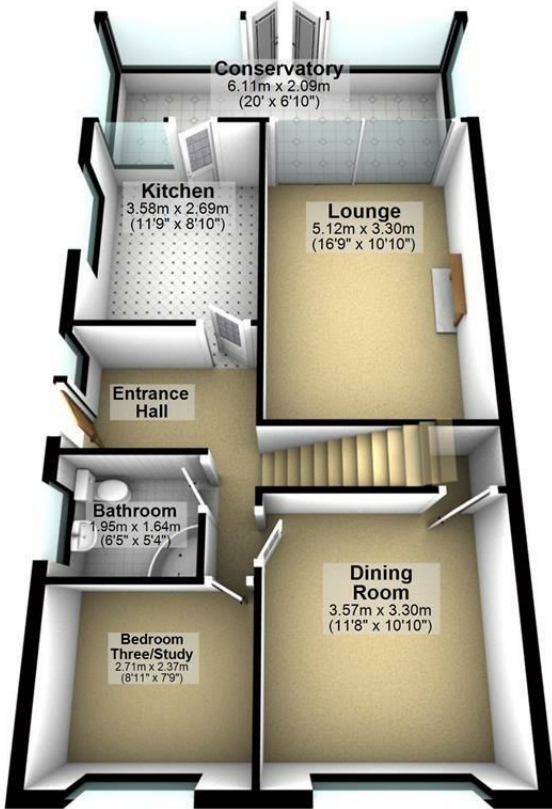

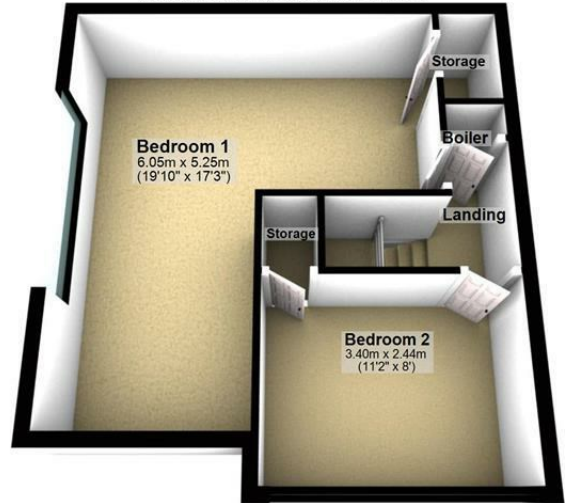
Ground Floor
