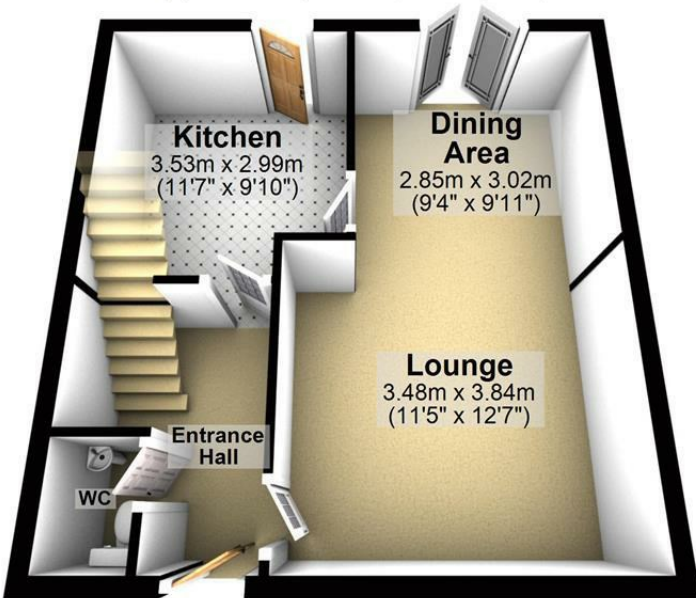

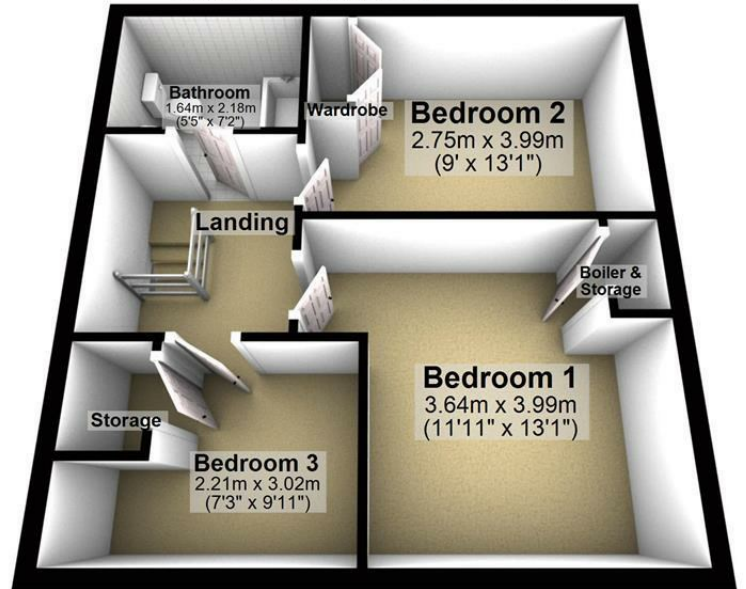
## Ground Floor
