

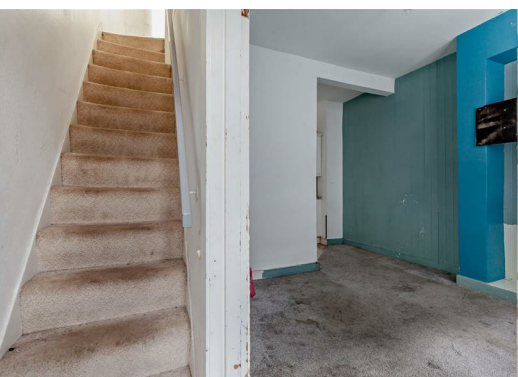


46 Brighton Avenue, Southend-On-Sea, SS1 2QN Offers in excess of £235,000
