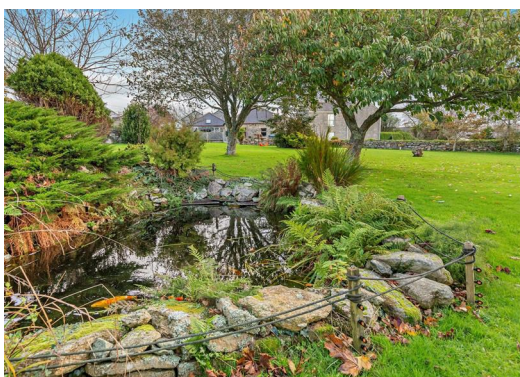
Goodmove present this 4 bedroom CONVERTED BARN for sale on Bodinnar Lane, Newbridge.
