

Rules on letting this property


Properties can be rented if they have an energy rating from A to E.

Properties are given a rating from A (most efficient) to G (least efficient).

Properties are also given a score. The higher this number, the lower your carbon dioxide (CO2) emissions are likely to be.

Environmental impact of this property

One of the biggest contributors to climate change is carbon dioxide (CO2). The energy used for heating, lighting and power in our homes produces over a quarter of the UK's CO2 emissions.

An average household produces	6 tonnes of CO2
This property produces	2.9 tonnes of CO2
This property's potential production	1.2 tonnes of CO2

By making the <u>recommended changes</u>, you could reduce this property's CO2 emissions by 1.7 tonnes per year. This will help to protect the environment.

How to improve this property's energy performance

Making any of the recommended changes will improve this property's energy efficiency.
