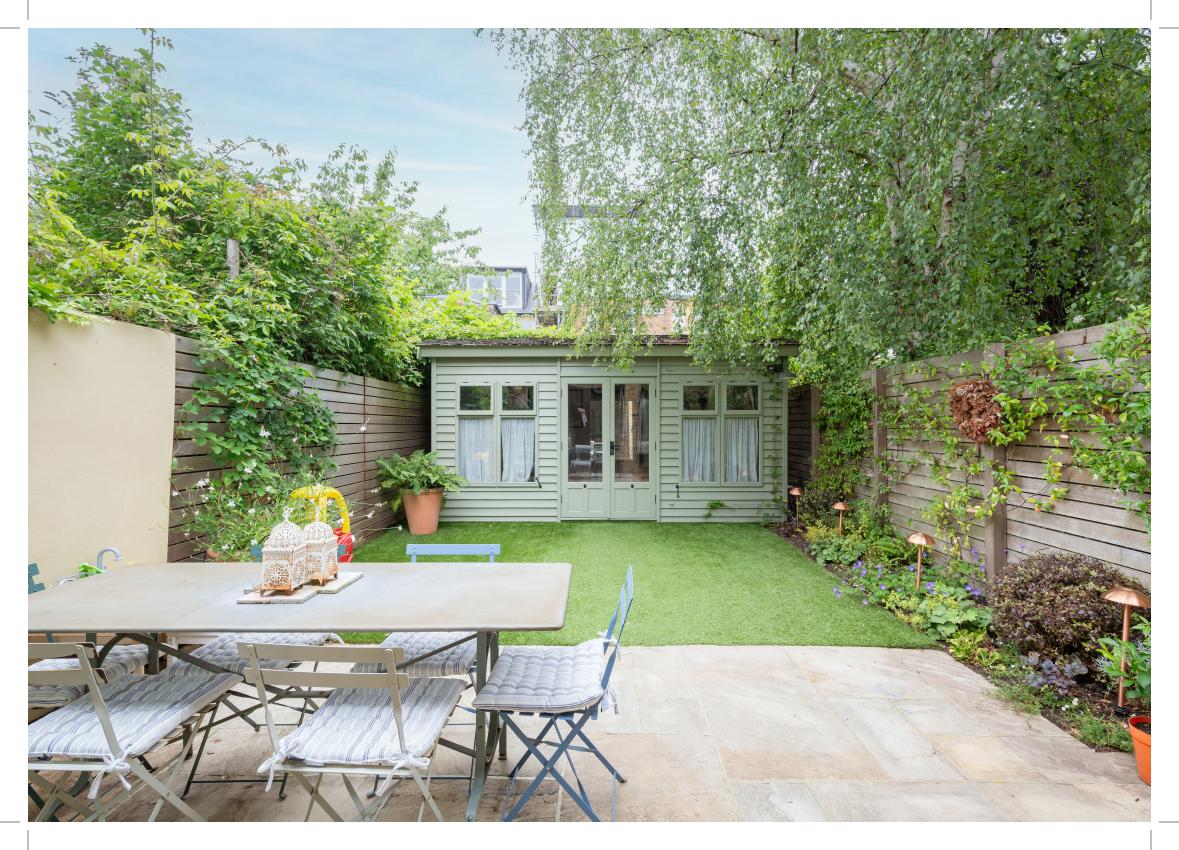


The entrance is beautifully lit by handmade stained-glass windows, setting an elegant tone from the outset.

In the living room, a striking decorative fireplace and original features are complemented by a classic bay window, while high ceilings and ornate cornicing reflect the homes character. The double reception room flows through to the standout kitchen with muted olive green cabinetry, brass hardware, and a large marble-topped island complete with a farmhouse sink. Bathed in natural light from expansive skylights and floor-to-ceiling sliding doors, the space opens directly onto the garden, creating a fluid indoor-outdoor living experience.

The landscaped garden is a private, leafy oasis, complete with climbing vines, mature planting, and a paved patio ideal for alfresco dining. A garden studio at the rear offers versatility, perfect for use as a home office, gym, or guest suite.

A private en suite, bay windows, and a Juliet balcony complete this serene retreat. Two additional bedrooms on the same floor provide ample space for family living. 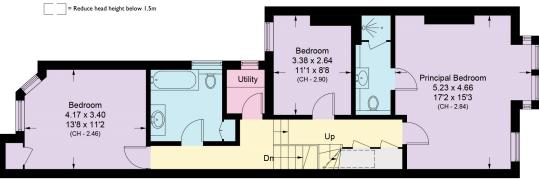
On the top floor, a spacious double bedroom with an adjoining shower room offers ideal accommodation for guests seeking privacy.

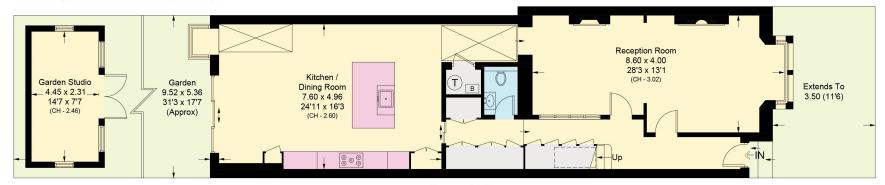
