Also on this level is a beautiful study with bespoke cabinetry and large sash windows that flood the room with natural light.

The lower ground floor, which benefits from its own private entrance, reveals a striking open-plan kitchen and dining area finished with contemporary microcement flooring. No expense has been spared with the bespoke Roundhouse kitchen, built in appliances and island overlooking the garden with separate walk in panty. Expansive glass doors open directly onto a generous south-facing garden with mature trees — a perfect setting for al fresco dining and outdoor gatherings. This floor also includes a versatile family room, a guest bedroom or storage room, and a stylish shower room.









On the first floor, a magnificent principal reception room with high ceilings, a bay window, and a period fireplace creates a true "wow" factor. A further double bedroom with built-in storage and access to a spacious family bathroom completes this level. The layout has been thoughtfully designed, with plumbing in place should a future owner wish to create a luxurious principal suite.

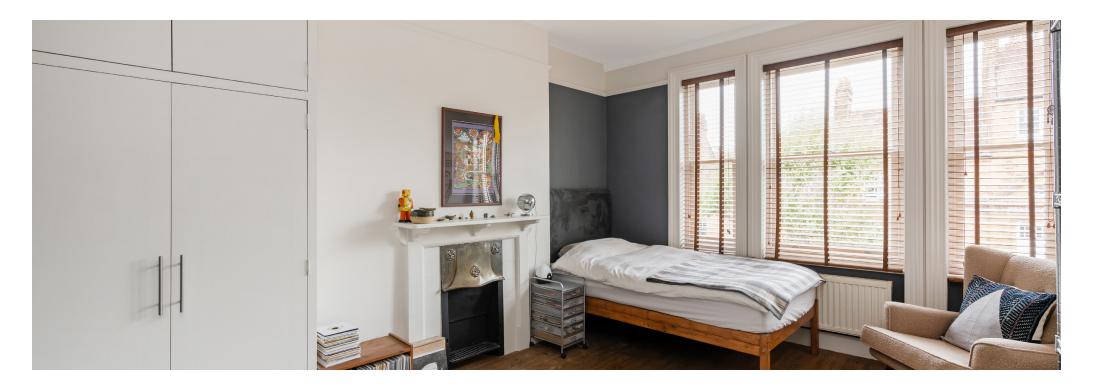
The upper floors comprise three additional bedrooms and a well-appointed bathroom with a convenient utility area.
