### Description

The subject property comprises a detached 2x storey period building of brick construction under a traditional pitched, slate roof. The property has been extended over time, with a single storey flat roof section to the rear.

The property is split into 2 separately demised areas, currently occupied by a ladies fashion store on the ground floor and a firm of solicitors at part ground floor and the first floor.


