LOCATION

The premises are located on the south bank of the River Tees and can be accessed via Dockside Road just off the A66/A171 Skippers Lane Interchange approximately 1.5 miles to the east of Middlesbrough town centre. The premises are located in an established industrial location with neighbouring occupiers being companies primarily in the engineering, fabrication and marine sectors best able to take advantage of the river frontage.

DESCRIPTION

The property comprises of an L-shaped site, comprising of concrete, tarmac, hard standing and grassed areas. The site is securely fenced and gated with access available to the River Tees via a third parties strip of land (further information is available on this upon application).

PLANNING & USE

The site is suitable for a variety of industrial uses subject to the appropriate planning consent. The site has had historic planning permission for waste management, however we recommend that interested parties make their own enquiries with the relevant authorities.

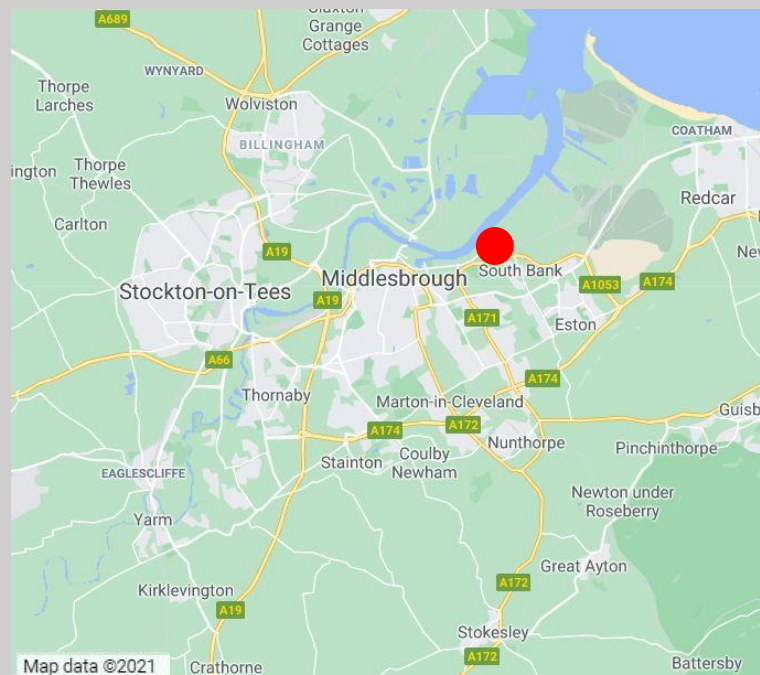
