#### LOCATION

The subject property is located on William Crosthwaite Avenue on the established Teesside Industrial Estate. The estate is situated to the south of Thornaby within the Teesside Conurbation lying adjacent to the A19 and approximately 2 miles from the A66.

## **DESCRIPTION**

The warehouse is of steel portal frame construction with part brick and block work elevations with profile metal cladding above and to the roof. The building has an eaves height of approximately 6.2 metres rising to 7.3 metres at the apex.

To the front of the building is ancillary office accommodation on the ground floor with a first-floor mezzanine above. Access to the workshop is by way of 2 roller shutter loading doors to the rear of the unit (approx. 4.8m wide x 5.2m high)..


