## FULL DESCRIPTION

Lawson are delighted to market this beautifully renovated top floor studio apartment in the former Regent Brewers. This Grade II listed Georgian building has been developed to an exceptionally high standard and comprises from six apartments in total, apartment 6 being found on the top floor. There is a video entry intercom phone system and a secure front door with carpeted stairs leading to the top floor, the front door opens straight into the open plan living area with a vaulted ceiling, a window to the front elevation and a luxury fitted kitchen.

The kitchen has an Neff electric oven, four burner Neff induction hob, filter canopy, fridge, stainless steel sink unit, attractive under unit lighting and a doorway to the shower room.

The shower room is fitted with a contemporary three piece suite with a floating WC, wash hand basin with storage beneath, oversized shower cubicle with a direct feed shower unit.

Bedroom area has two windows to the rear elevation.

The whole apartment is fitted high quality grey wash oak LVT flooring.

Externally, there is secure allocated parking for one vehicle. The carpark and entrance are both covered by a communal CCTV system.

This property is held on a leasehold basis with a new lease of 999 years in place and has an annual service charge of £854 - £1,401.

## PLYMOUTH
